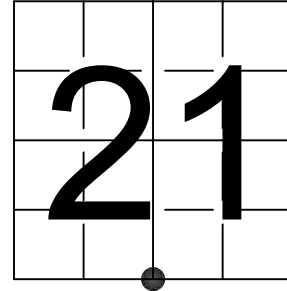

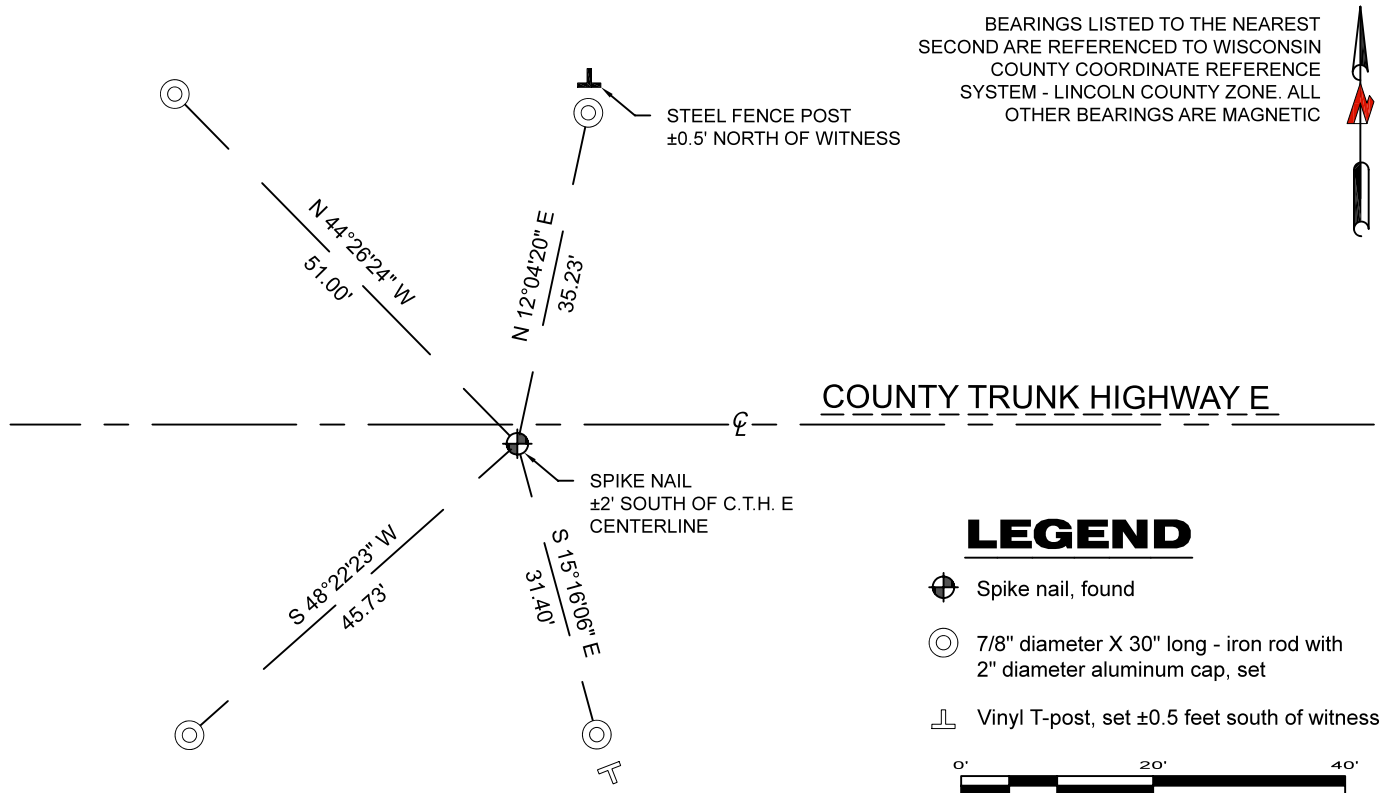

January 26, 2010 - Surveyor 2729 - Gregory S. Maines - indicate this position as "N174635.65, E346283.64 provided by Lincoln County" on Lincoln County Section Summary - Section 28, T 33 N, R 5 E.

June 29, 2022 - While performing the 2022 Lincoln County PLSS Corner Remonumentation and GPS Services project, I found a vertical spike nail near the computed position provided by Lincoln County. The monument is ±2 feet south of the of C.T.H. E centerline, and ±6" below road grade. I established 4 new reference monuments as shown below.

A-E 7.08(3)(c)(d) Plan view of corner with references to at least 4 witness monuments.




A-E 7.08(3)(e) 1854 Surveyor set a post, 2010 Surveyor had coordinates. I found a spike nail.

A-E 7.08(3)(f) I accept this monument as a FOUND PERPETUATED LOCATION of the corner.

A-E 7.08(3)(g)(h) This corner was not determined through lost-corner-proportionate methods.
