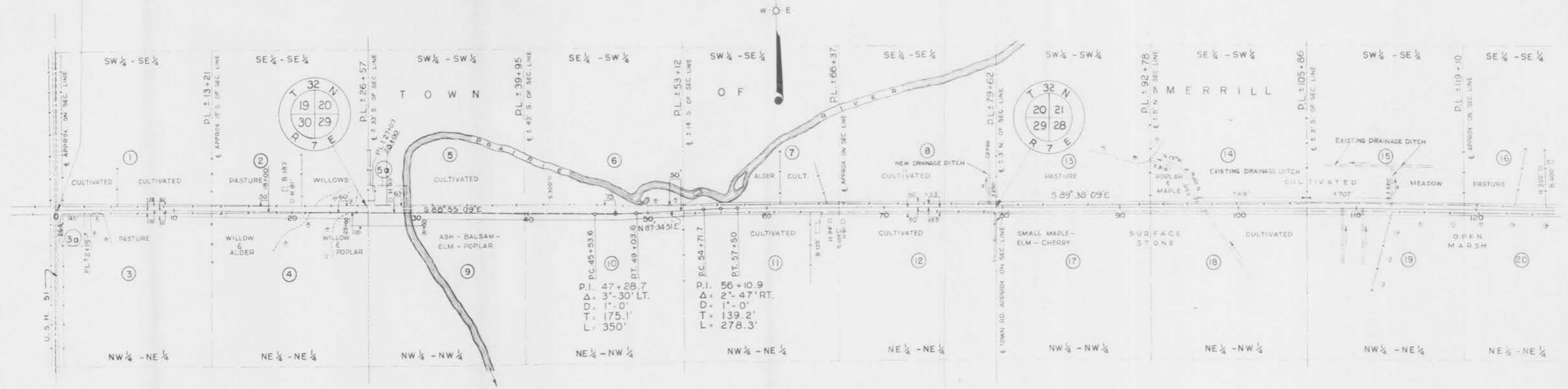


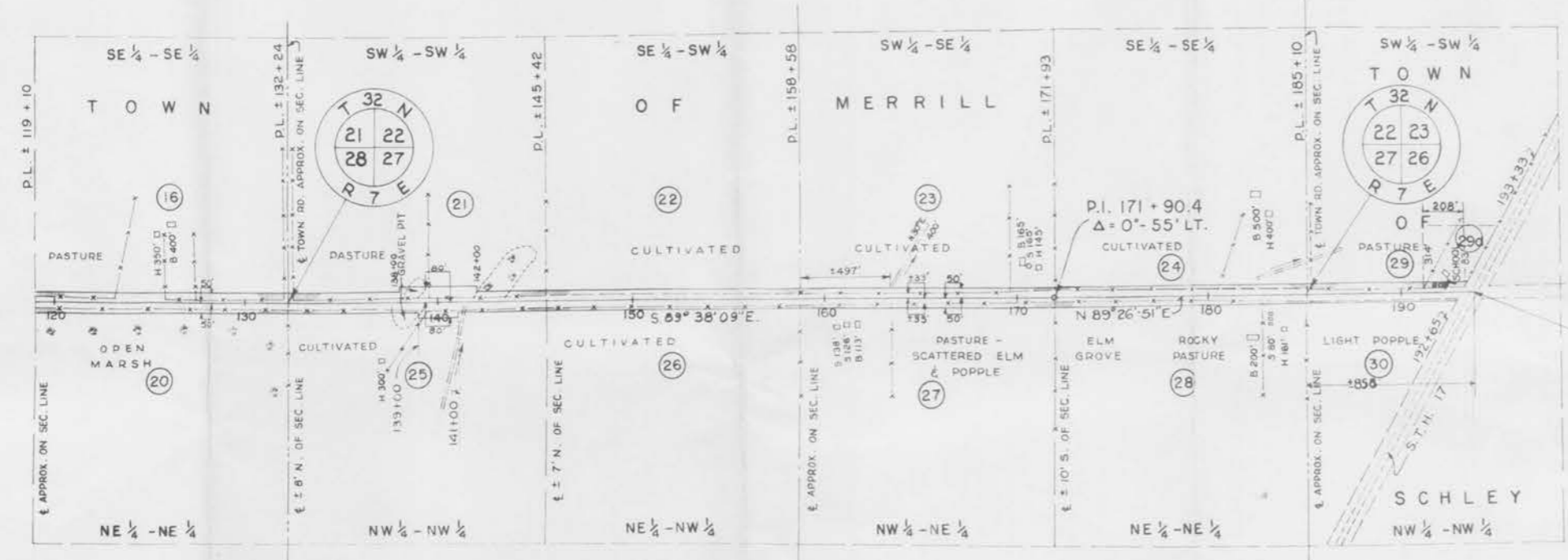

STA. 0+10 BEGINNING PROJ. S-0192(3)



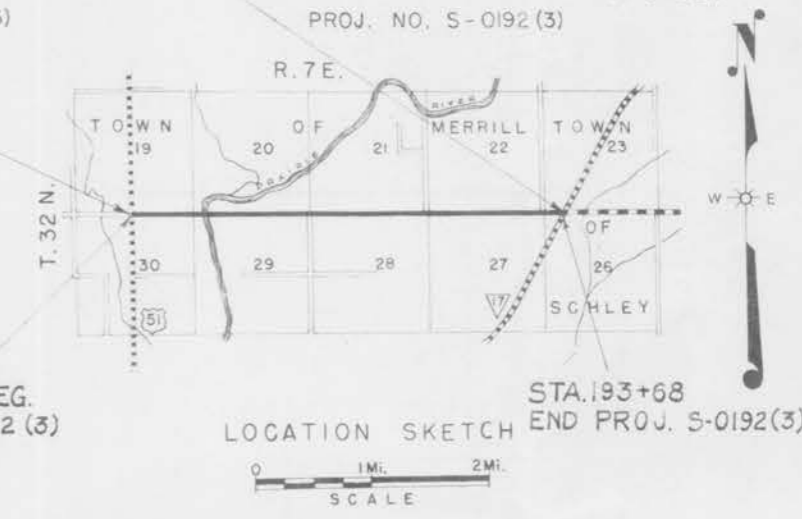
STA. 0+00 BEG. OF RELOC. ORDER
