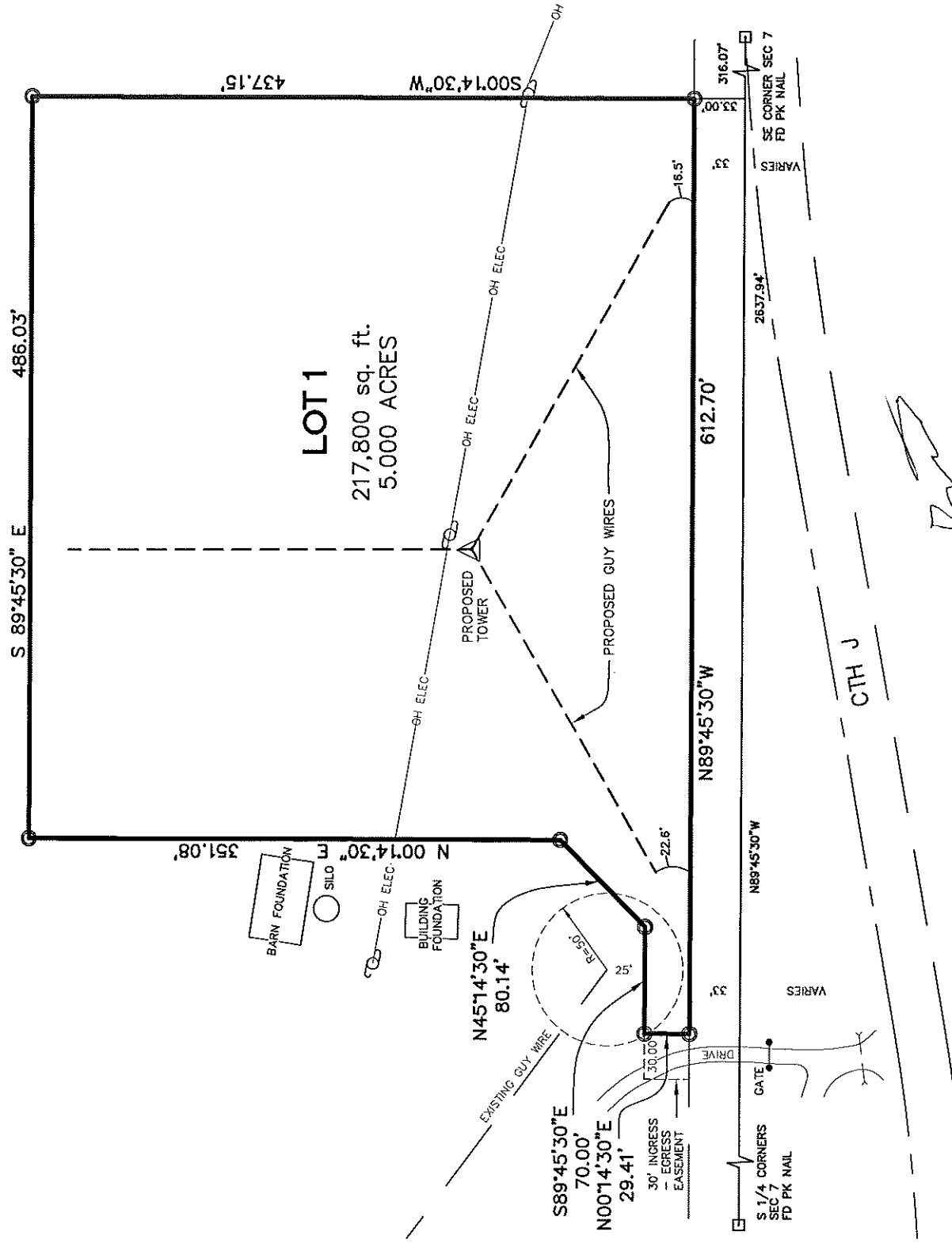


CERTIFIED SURVEY MAP

OF BIRCH, LINCOLN COUNTY WISCONSIN



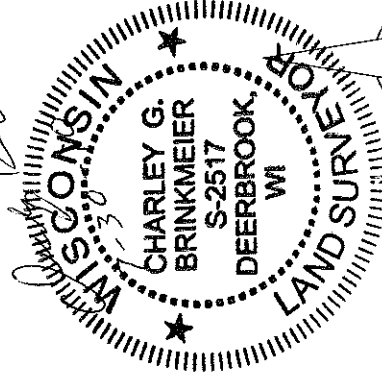

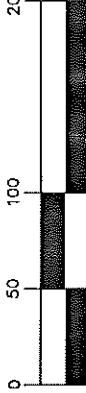

I, Charley G. Brinkmeier, Registered Land Surveyor, hereby certify:

That I have surveyed, and mapped by the order of Alan Kilgore of WRVM, Inc., land being part of the Southeast ¼ of the Southeast ¼ of Section 7, Township 33 North, Range 7 East, Town of Birch, Lincoln County, Wisconsin more particularly described as follows:

Commencing at the Southeast corner of Section 7 thence N89° 45' 30"W, 316.07 feet along the South line of the Southeast ¼ of Section 7; thence N00° 14' 30"E, 33.00 feet to the Northerly R/W line of CTH J and the point of beginning of the parcel herein described; thence N89° 45' 30"W, 612.70 feet along the Northerly R/W line of CTH J; thence N0° 14' 30"E, 29.41 feet; thence S89° 45' 30"E, 70.00 feet; thence N45° 14' 30"E, 80.14 feet; thence N0° 14' 30"E, 351.08 feet; thence S89° 45' 30"E, 486.03 feet; thence S0° 14' 30"W, 437.15 feet to the point of beginning of the parcel herein described.

Said parcel contains 217,800 Square Feet or 5.000 Acres.

Subject to all roadways and easements of record.

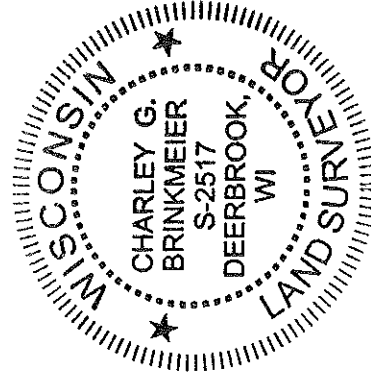
