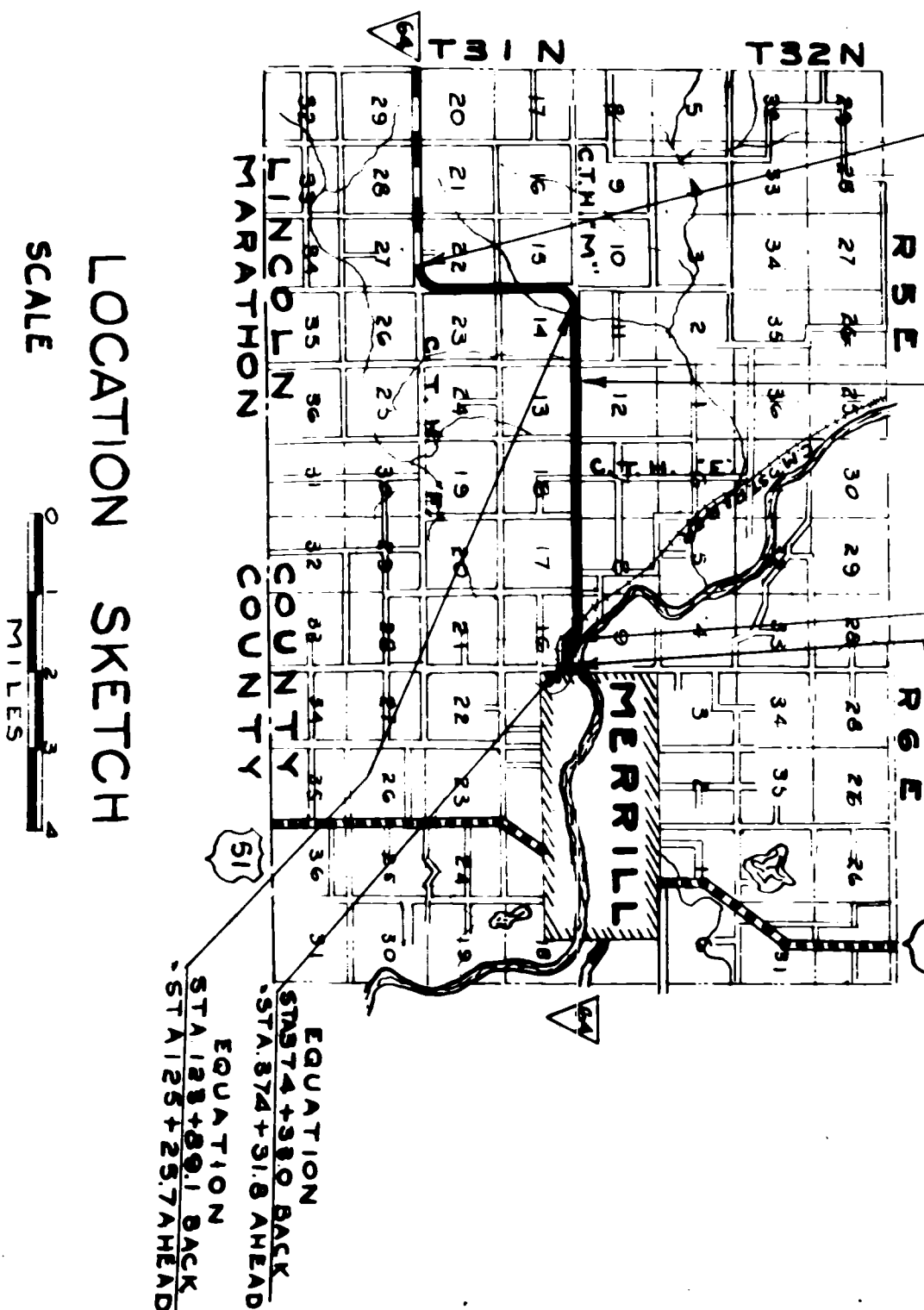

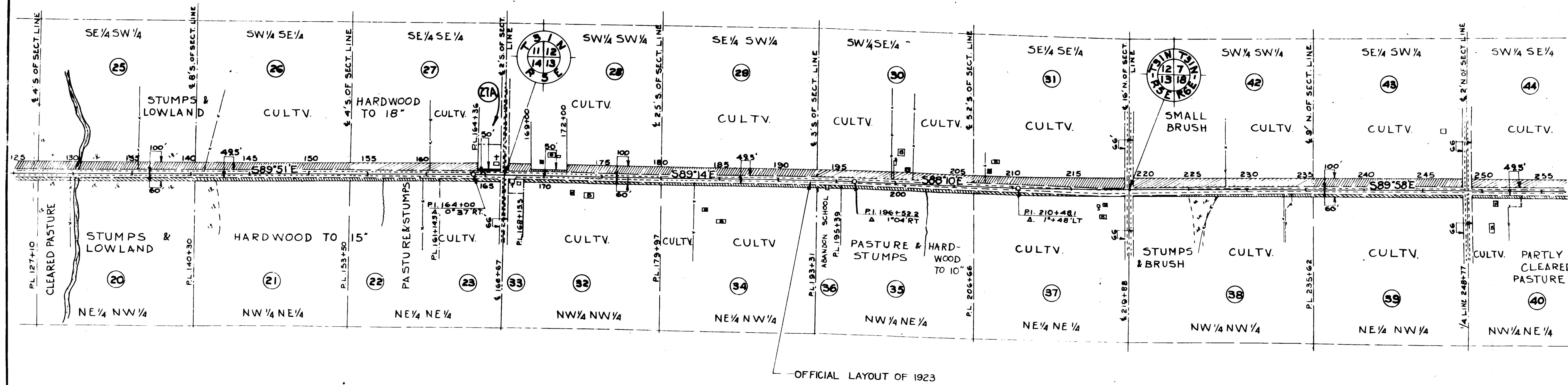
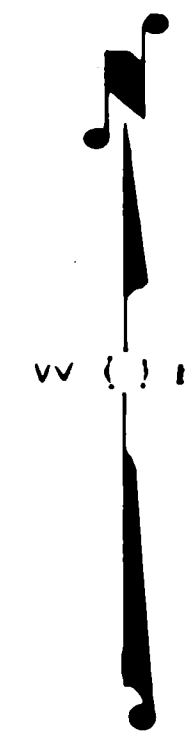
LOCATION SKETCH

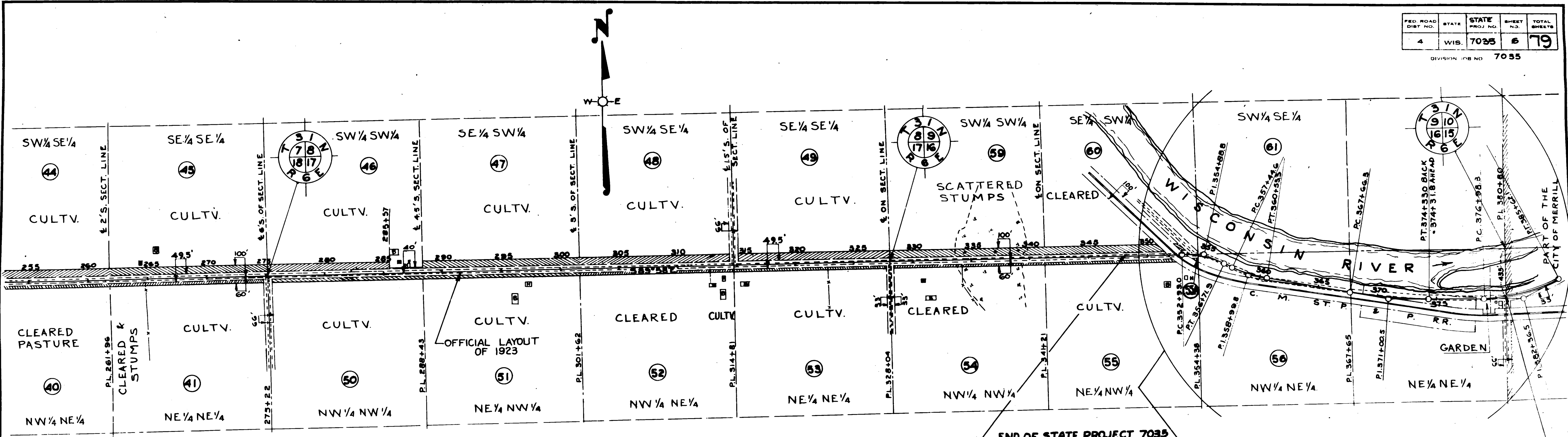

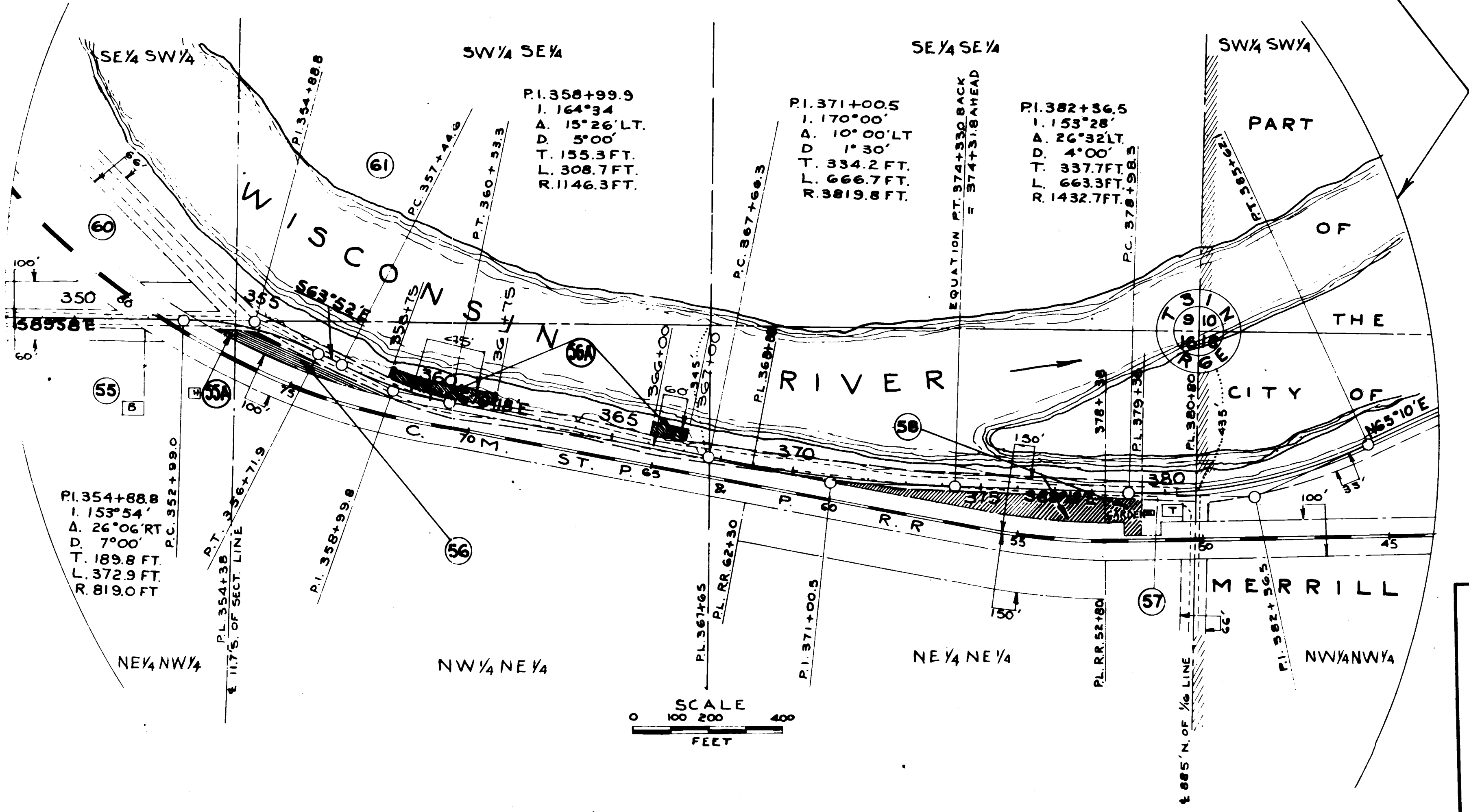
