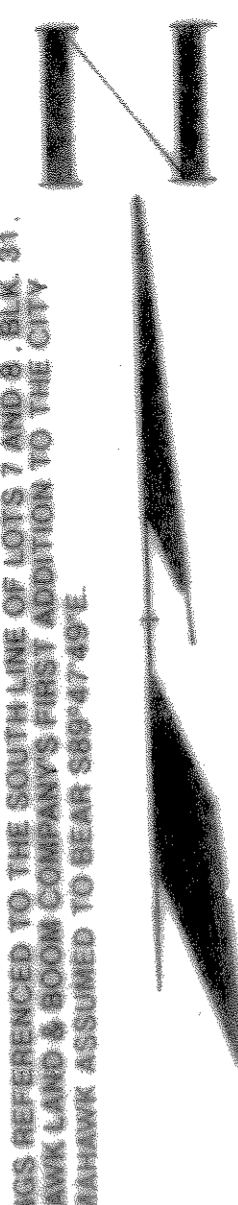
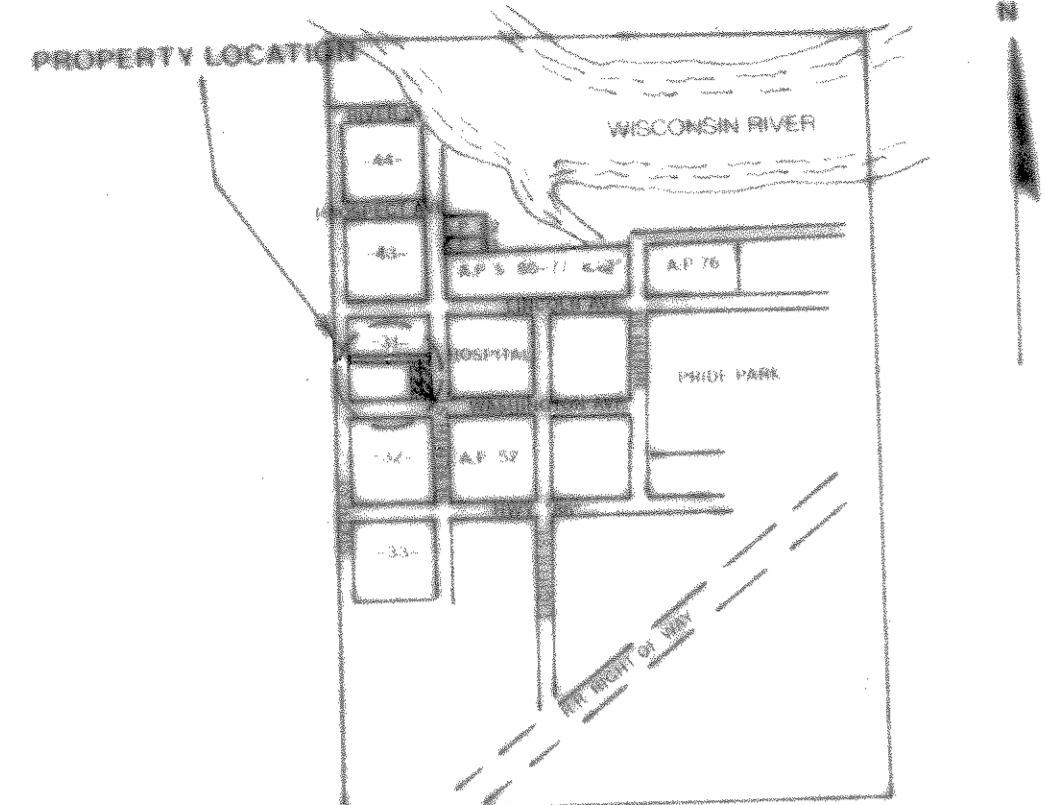

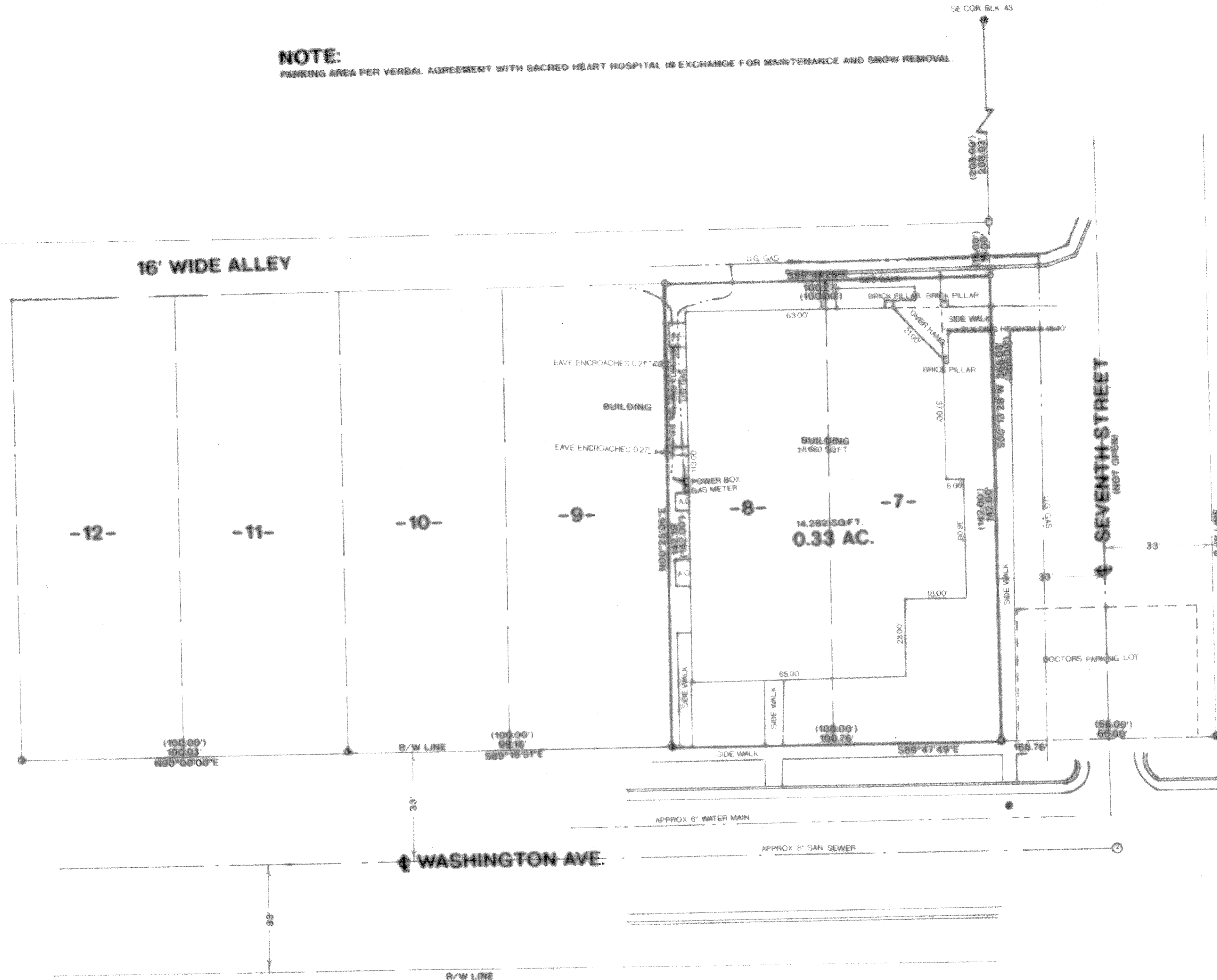
LOCATION SKETCH
