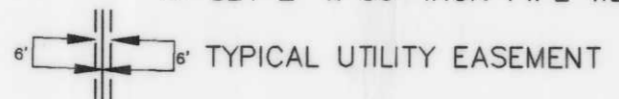

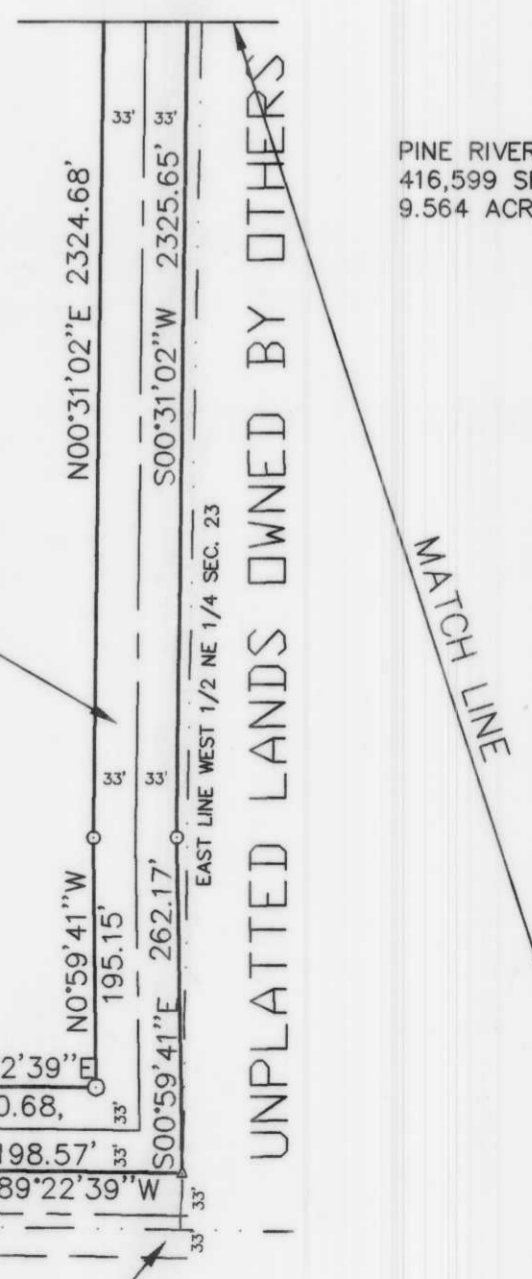
LOCATION SKETCH
