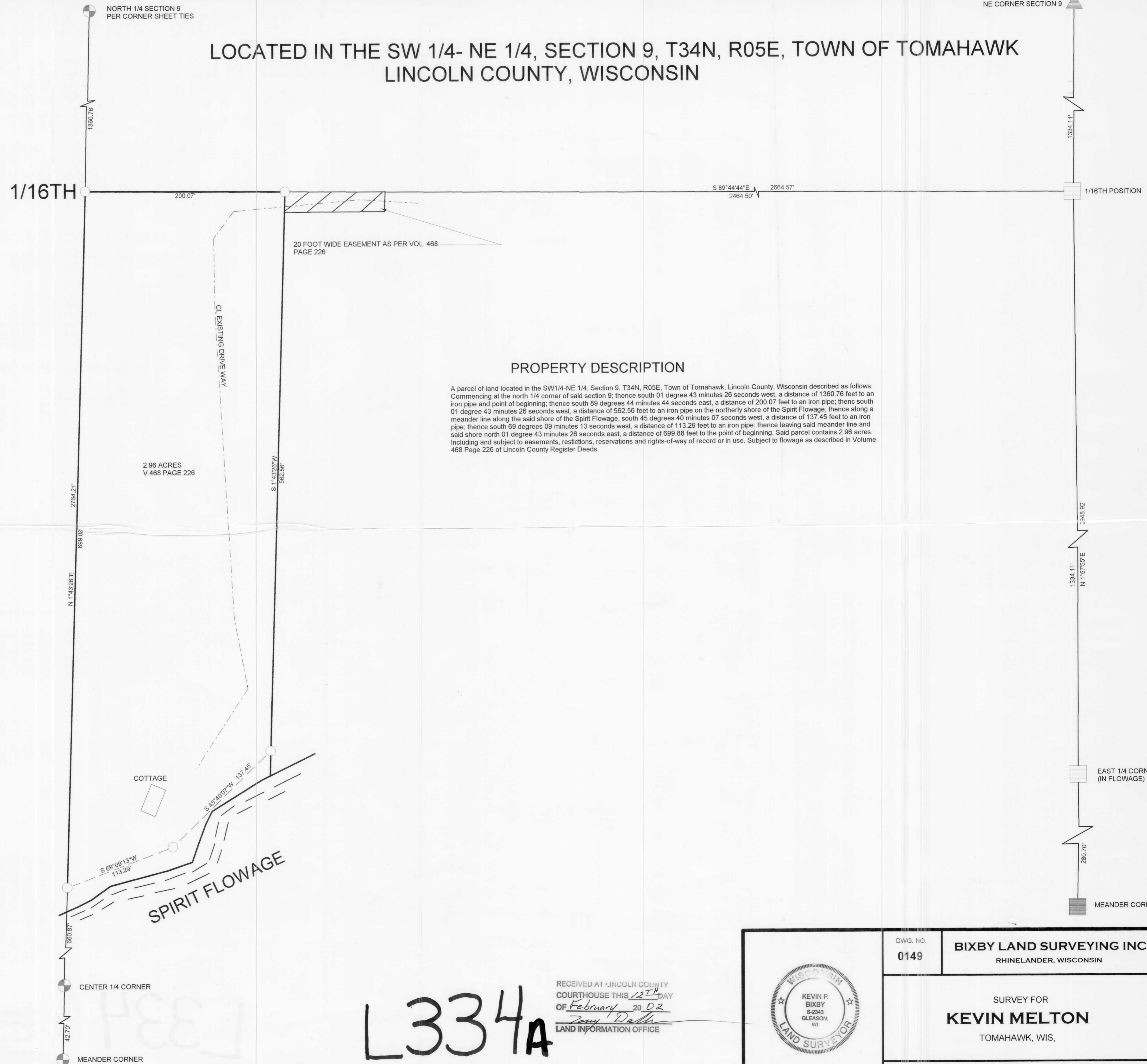


BERINGS REF. TO THE EAST LINE SECTION 9 T34N, R05E ASSUMED TO BEAR N 1°57'55"E

PROPERTY DESCRIPTION

A parcel of land located in the SW1/4-NE 1/4, Section 9, T34N, R05E, Town of Tomahawk, Lincoln County, Wisconsin described as follows: Commencing at the north 1/4 corner of said section 9; thence south 01 degree 43 minutes 26 seconds west, a distance of 1360.76 feet to an iron pipe and point of beginning; thence south 89 degrees 44 minutes 44 seconds east, a distance of 200.07 feet to an iron pipe; thence south 01 degree 43 minutes 26 seconds west, a distance of 562.56 feet to an iron pipe on the northerly shore of the Spirit Flowage; thence along a meander line along the said shore of the Spirit Flowage, south 45 degrees 40 minutes 07 seconds west, a distance of 137.45 feet to an iron pipe; thence south 69 degrees 09 minutes 13 seconds west, a distance of 113.29 feet to an iron pipe; thence leaving said meander line and said shore north 01 degree 43 minutes 26 seconds east, a distance of 699.88 feet to the point of beginning. Said parcel contains 2.96 acres, including and subject to easements, restrictions, reservations and rights-of-way of record or in use. Subject to flowage as described in Volume 468 Page 226 of Lincoln County Register Deeds.
