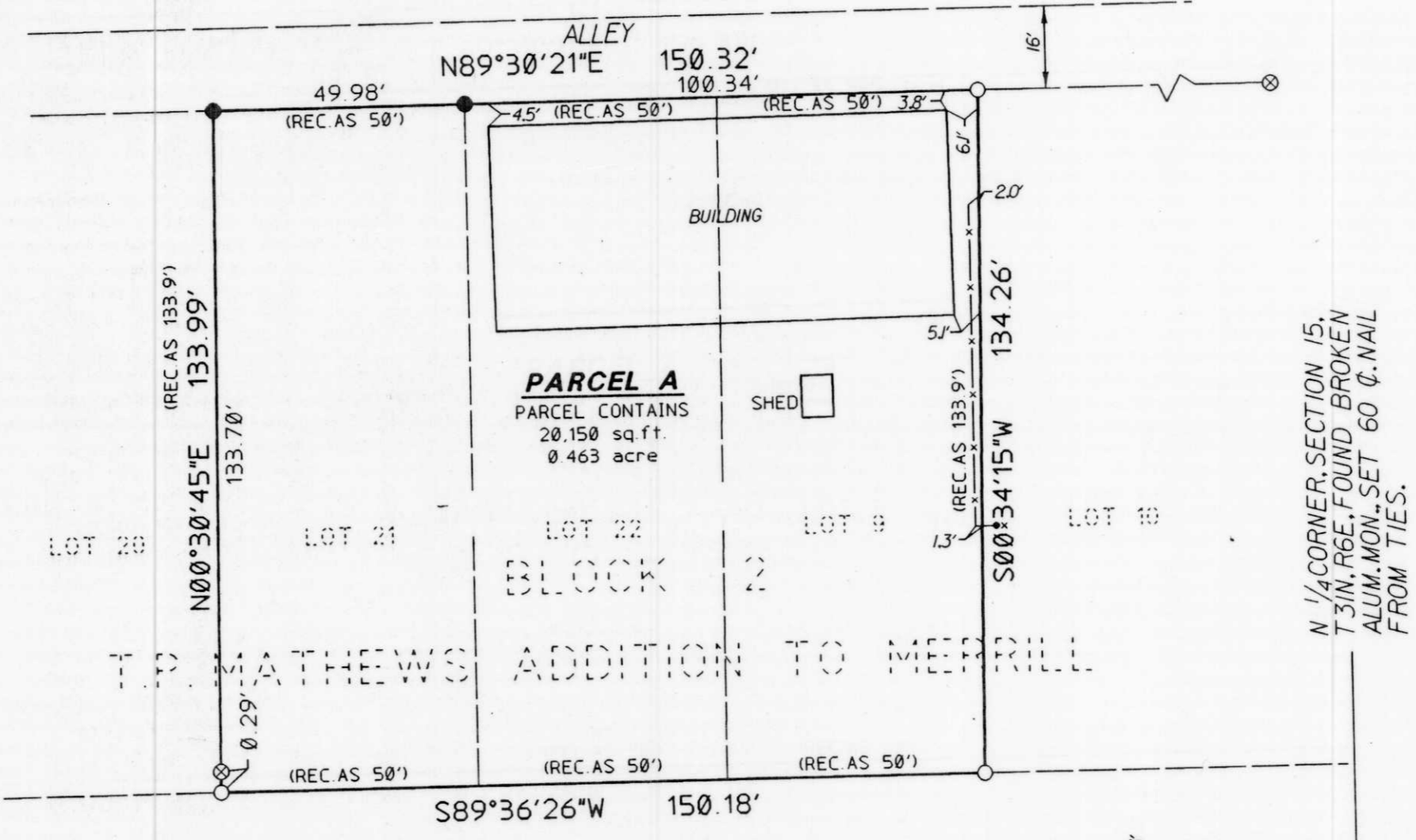

**DESCRIPTIONS**

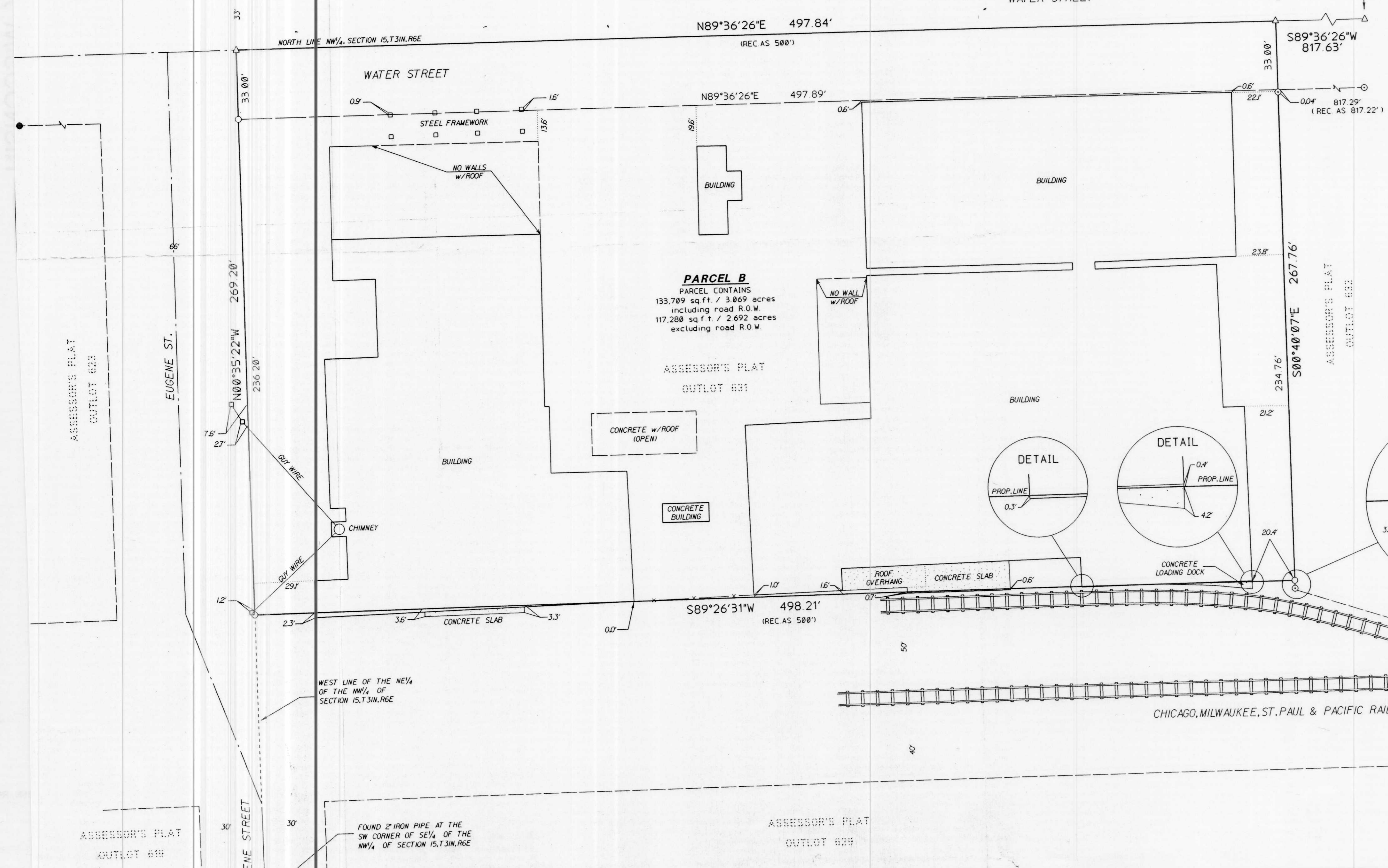
**Parcel A:** Lots 9, 21, and 22 of Block 2 of T.P. MATHEWS ADDITION TO MERRILL, LOCATED IN THE SE 1/4 OF THE SW 1/4 OF SECTION 10, T31N, R6E, CITY OF MERRILL, LINCOLN COUNTY, WISCONSIN. This parcel contains 0.463 acre, more or less.

**Parcel B:** OUTLOT 631 OF THE ASSESSOR'S PLAT OF THE CITY OF MERRILL, LOCATED IN THE NE 1/4 OF THE NW 1/4 OF SECTION 15, T31N, R6E, CITY OF MERRILL, LINCOLN COUNTY, WISCONSIN. MORE FULLY DESCRIBED AS FOLLOWS:

Commencing at the North 1/4 corner of said Section 15; thence S89°36'26"W, 817.63 feet along the North line of the NW 1/4 of said Section 15 to the Northeast corner of said Outlot 631 and the point of beginning of this description; thence S0°40'07"E, 267.76 feet along the East line of said Outlot 631; thence S89°26'31"W, 498.21 feet (previously recorded as 500 feet) along the South line of said Outlot 631 being a line 50 feet North of and parallel with the centerline of the original tracks of the Chicago, Milwaukee, St Paul and Pacific Railroad to a point on the West line of the NE 1/4 of the NW 1/4 of said Section 15 which is 90 feet North of the South right-of-way line of said Railroad; thence N0°35'22"W, 269.20 feet along said West line to the North line of the NW 1/4 of said Section 15; thence N89°36'26"E, 497.84 feet (previously recorded as 500 feet) along said North line to the point of beginning of this description. This parcel contains 3.069 acres, more or less, including the right-of-way of Water Street. This parcel contains 2.692 acres, more or less, excluding said right-of-way.
