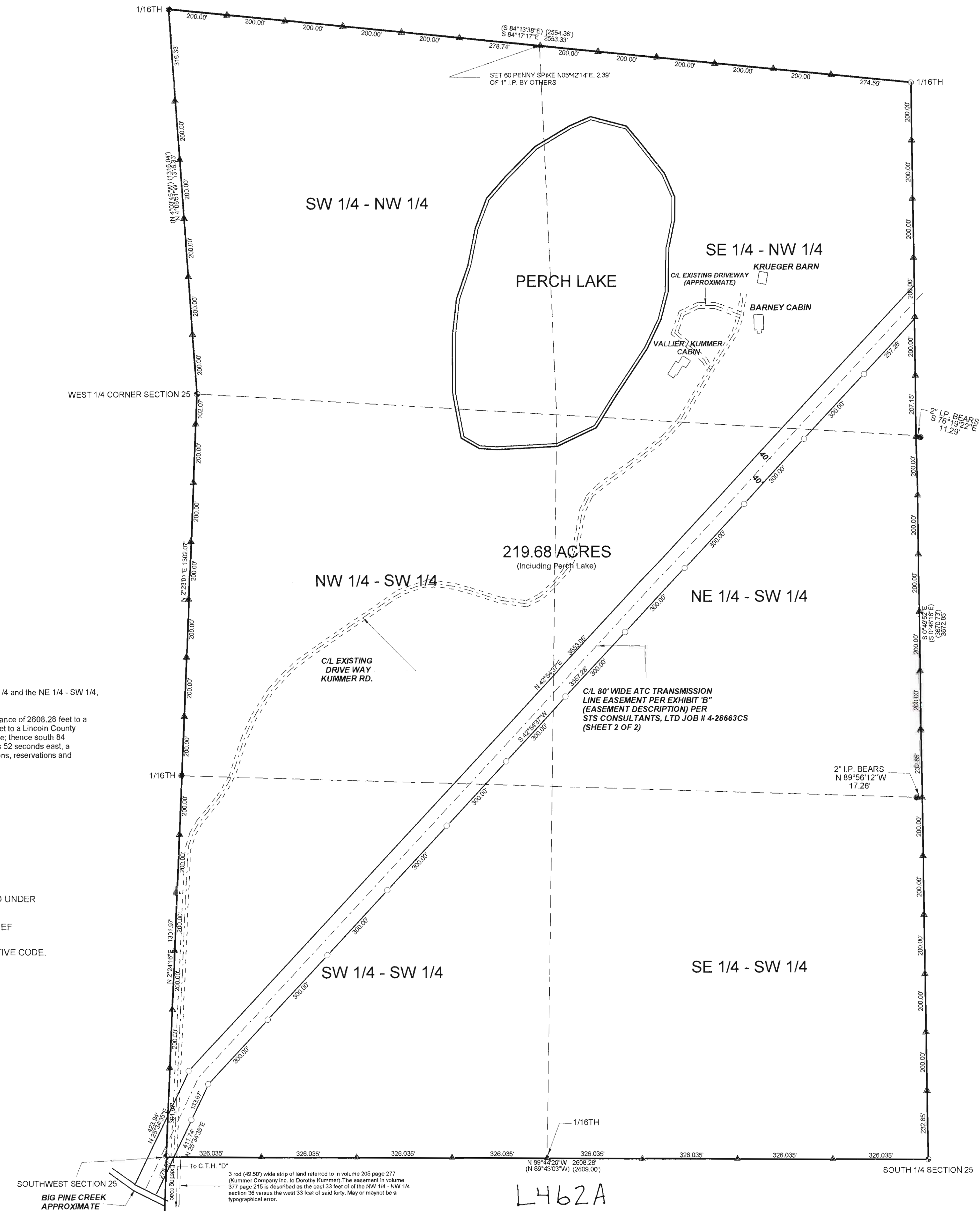

PROPERTY DESCRIPTION

A parcel of land located in the SE 1/4 - SW 1/4, SW 1/4 - SW 1/4, NW 1/4 - SW 1/4, SW 1/4 - NW 1/4 and the NE 1/4 - SW 1/4, section 25, T35N, R07E, Town of King, Lincoln County, Wisconsin described as follows:
 Commencing at the south 1/4 corner of said section 25; thence north 89 degrees 44 minutes 20 seconds west, a distance of 2608.28 feet to a Lincoln County bernstein monument; thence north 02 degrees 23 minutes 39 seconds east, a distance of 2004.04 feet to a Lincoln County bernstein monument; thence north 04 degrees 06 minutes 51 seconds west, a distance of 1316.33 feet to an iron pipe; thence south 84 degrees 17 minutes 17 seconds east, a distance of 2553.33 feet to an iron pipe; thence south 00 degrees 49 minutes 52 seconds east, a distance of 3672.85 feet to the point of beginning. Said parcel contains 219.68 acres. Subject to easements, restrictions, reservations and rights of way of record or in use.
