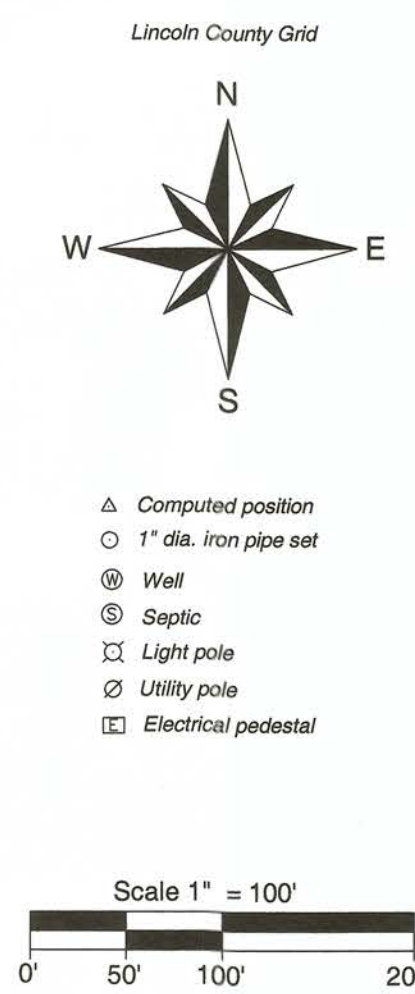

BEGINNING at the West 1/4 Corner of said Section 15 marked by a granite stone monument; thence along the west line of said Section 15, N00°25'24"E for a distance of 1017.27 feet to the southwest corner of the North 1/2 of the SW 1/4 of the NW 1/4, marked with an iron pipe; thence along the south line of said North 1/2 of the North 1/2 of the SW 1/4 of the NW 1/4, N87°53'12"E for a distance of 1322.13 feet to the southeast corner of said North 1/2 of the North 1/2 of the SW 1/4 of the NW 1/4, marked by an iron pipe; thence along the east line of the SW 1/4 of the NW 1/4, S00°22'20"W for a distance of 1026.31 feet to the southeast corner of said SW 1/4 of the NW 1/4, marked by an iron pipe; thence along the south line of said SW 1/4 of the NW 1/4, S87°24'52"W for a distance of 1323.56 feet to the PLACE OF BEGINNING. Subject to the rights of the public over the town road known as Bridge Road.
