

RESULTS OF SURVEY

FOR A 2.871 ACRE PARCEL LOCATED IN THE NE 1/4 SW 1/4 SECTION 13, TOWNSHIP 31 NORTH, RANGE 6 EAST, TOWN of SCOTT, LINCOLN COUNTY, WISCONSIN

LEGAL DESCRIPTION

A parcel of land located in the NE 1/4 SW 1/4 of section 13, township 31 North, Range 6 East, Town of Scott, Lincoln County, Wisconsin. Being more particularly described as follows: Commencing at the center 1/4 corner of said section 13, a found stone, thence; S 00° 13' 15" E along the center section line a distance of 1,305.00 feet to a set 1" iron pipe, thence; S 89° 55' 58" W a distance of 732.39 feet to the easterly right-of-way of a road (recorded in Vol. 395, Page 636 LCR), thence; N 32° 00' 00" W along said right-of-way, a distance of 6.12 feet to a set 1" iron pipe being the POINT OF BEGINNING of this description, thence; leaving said right-of-way, N 47° 13' 52" E a distance of 998.50 feet to a set 1" iron pipe on said center section line, thence; N 00° 13' 15" W along said section line a distance of 162.89 feet to a set 1" iron pipe, thence; leaving said section line, S 47° 13' 52" W a distance of 1,085.82 feet to a set 1" iron pipe on the easterly right-of-way of said road, thence; S 32° 00' 00" E along said right-of-way a distance of 122.15 feet to the POINT OF BEGINNING.

Said parcel contains 125,059,0570 sq. Ft. (2.8710 Acres)

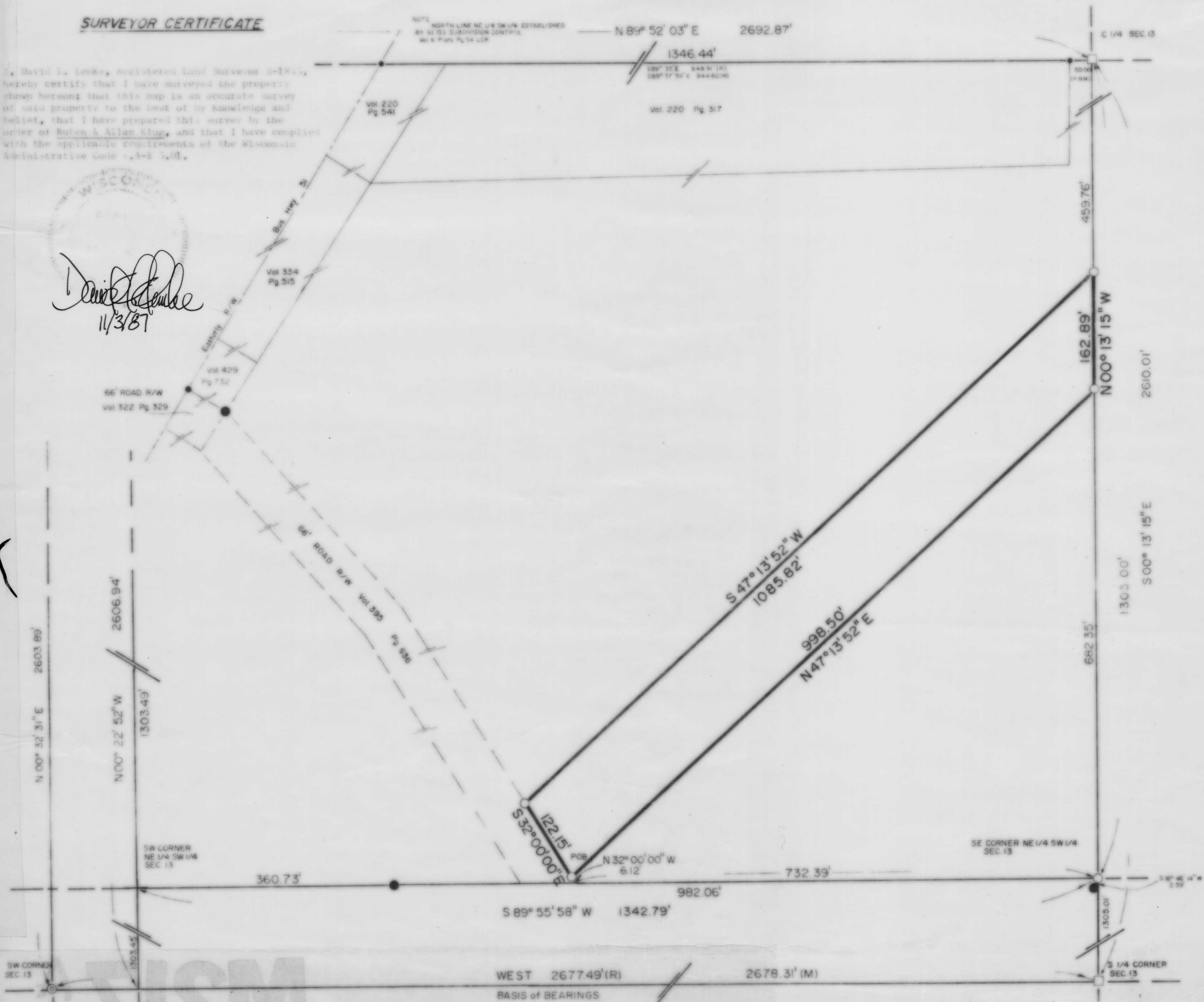
