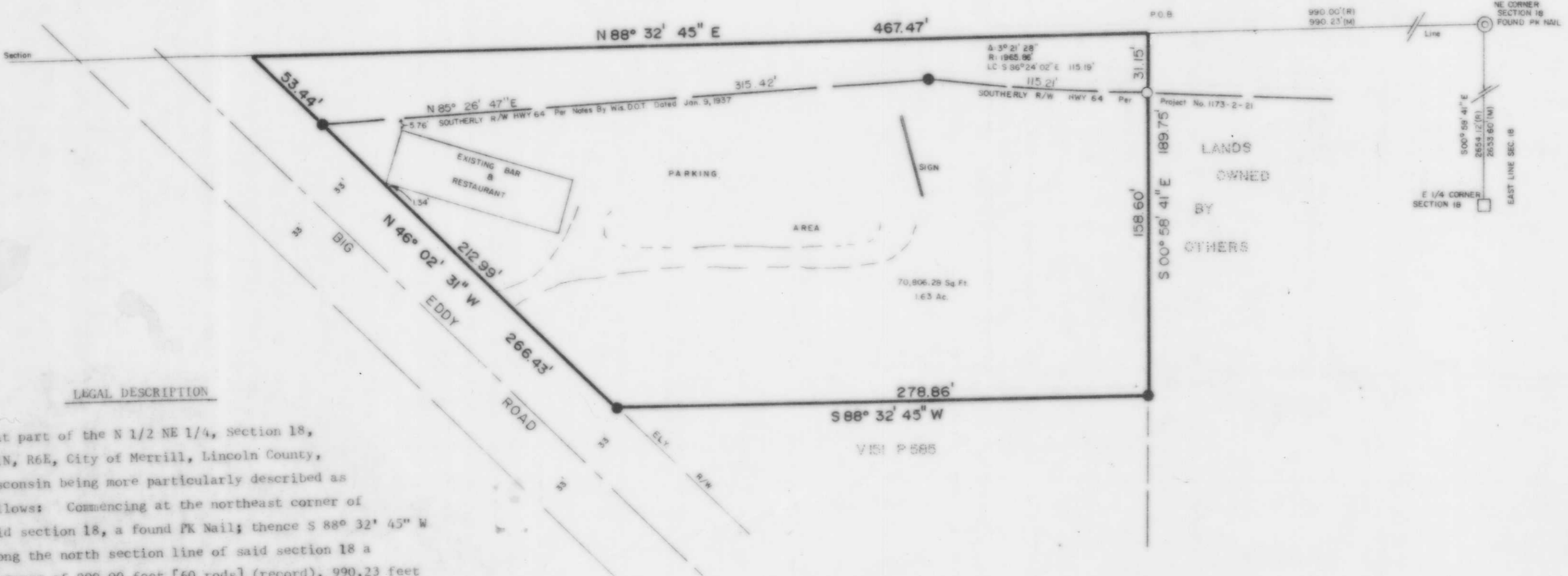


# BOUNDARY SURVEY

CITY OF MERRILL, LINCOLN COUNTY, WISCONSIN

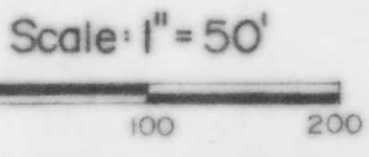
**LEGAL DESCRIPTION**

That part of the N 1/2 NE 1/4, Section 18, T31N, R6E, City of Merrill, Lincoln County, Wisconsin being more particularly described as follows: Commencing at the northeast corner of said section 18, a found PK Nail; thence S 88° 32' 45" W along the north section line of said section 18 a distance of 990.00 feet [60 rods] (record), 990.23 feet (measured) to a point within the right-of-way of State Highway 64 being the POINT OF BEGINNING of this description; thence S 00° 58' 41" E [11.5 rods] a distance of 189.75 feet to a set 1" iron rod; thence S 88° 32' 45" W a distance of 278.86 feet to a set 1" iron rod on the easterly right-of-way of Big Eddy Road (formerly known as Old Wausau Road & Old Hwy. "W"); thence N 46° 02' 31" W along said right-of-way a distance of 266.43 feet to its intersection with the north line of said section 18; thence N 88° 32' 45" E along said section line a distance of 467.47 feet to the POINT OF BEGINNING.

Subject to and together with any and all easements, restrictions and right-of-ways of record and or of use. Said parcel contains 1.63 acres.
