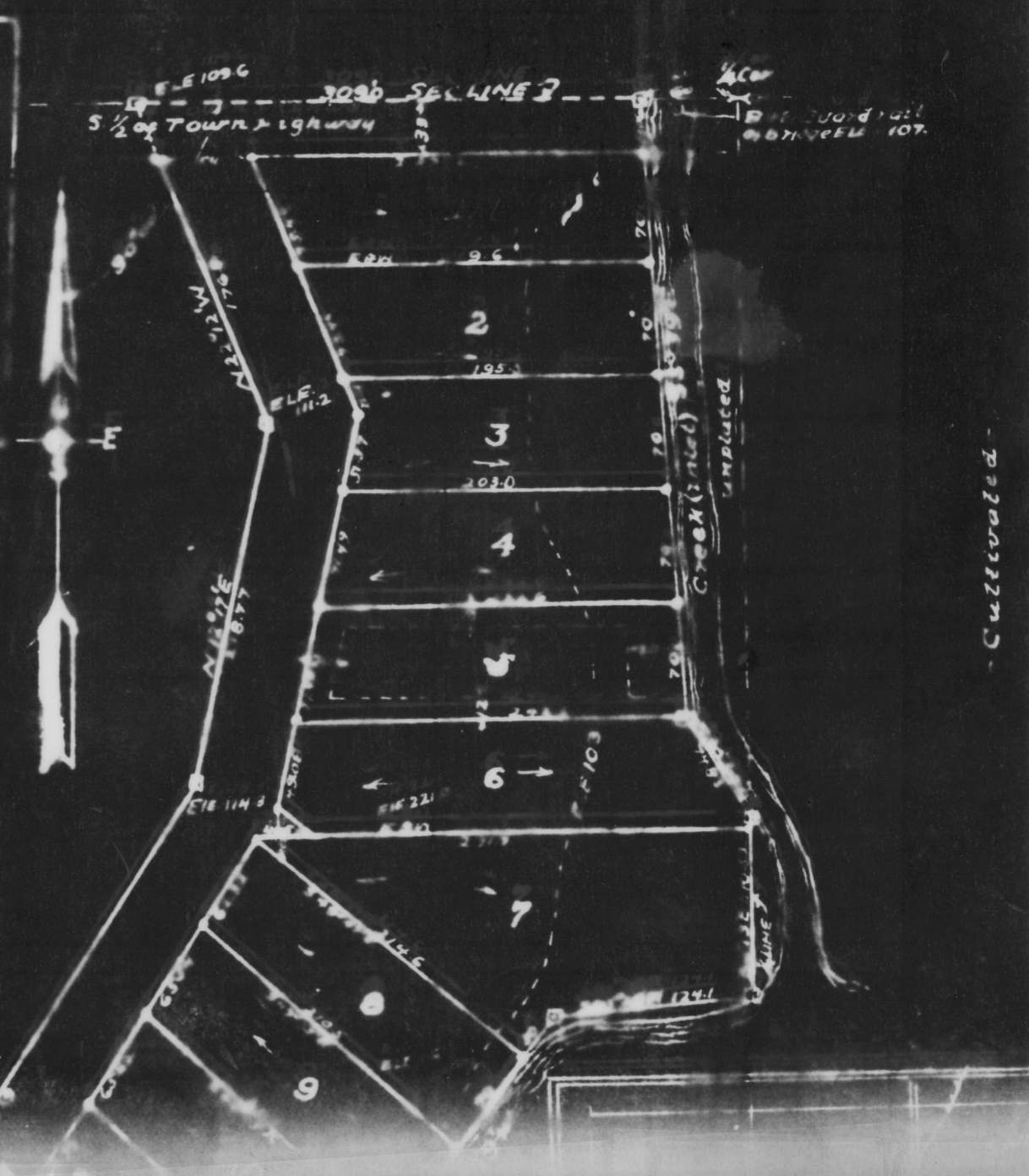

Lot 1 of Section 35 of Township 33 N of Range 6 E, described as follows: Commencing on the North Section Line of said Sec. 35, 600ft west from the North Quarter Post of said section, thence running S. 3°39'E 452.06ft, thence S 30°34'E. 74.83 ft, thence S 0°19'E on the 1/4 line 110.52 ft, thence S. 86°20'W 124.1 ft, thence S 87°39'W. 105.0 ft, thence S. 0°58'E 200ft, thence S 69°20'E 120ft, thence S 3°42'W. 42.0ft, thence S 38°30'W. 76.0ft, thence S 27°15'E 174.0ft to the 1/2 line, thence S 09°58'W on the 1/2 line 377.9 ft, thence N 3°47'E 210.6 ft, thence N 6°04'W. 296.10ft, thence N 33°29'E 499.20ft, thence N 12°17'E. 210.77ft thence N 22°12'W 212.45ft to the said North Sec. Line, thence E. on the Section Line 309.00ft to the place of commencement. All the courses being taken from the North Section Line as running due East and West. All angle points marked thus \square I have placed re-encased concrete monuments 6" in diameter by 36" long. At all corners and angle points marked thus \circ I have placed iron pipe 1" diameter by 24" long and longer. Set back lines are shown by dotted lines in lots and distances from boundary of same apply to all lots. The map is a true representation of the land surveyed and subdivisions therein made. 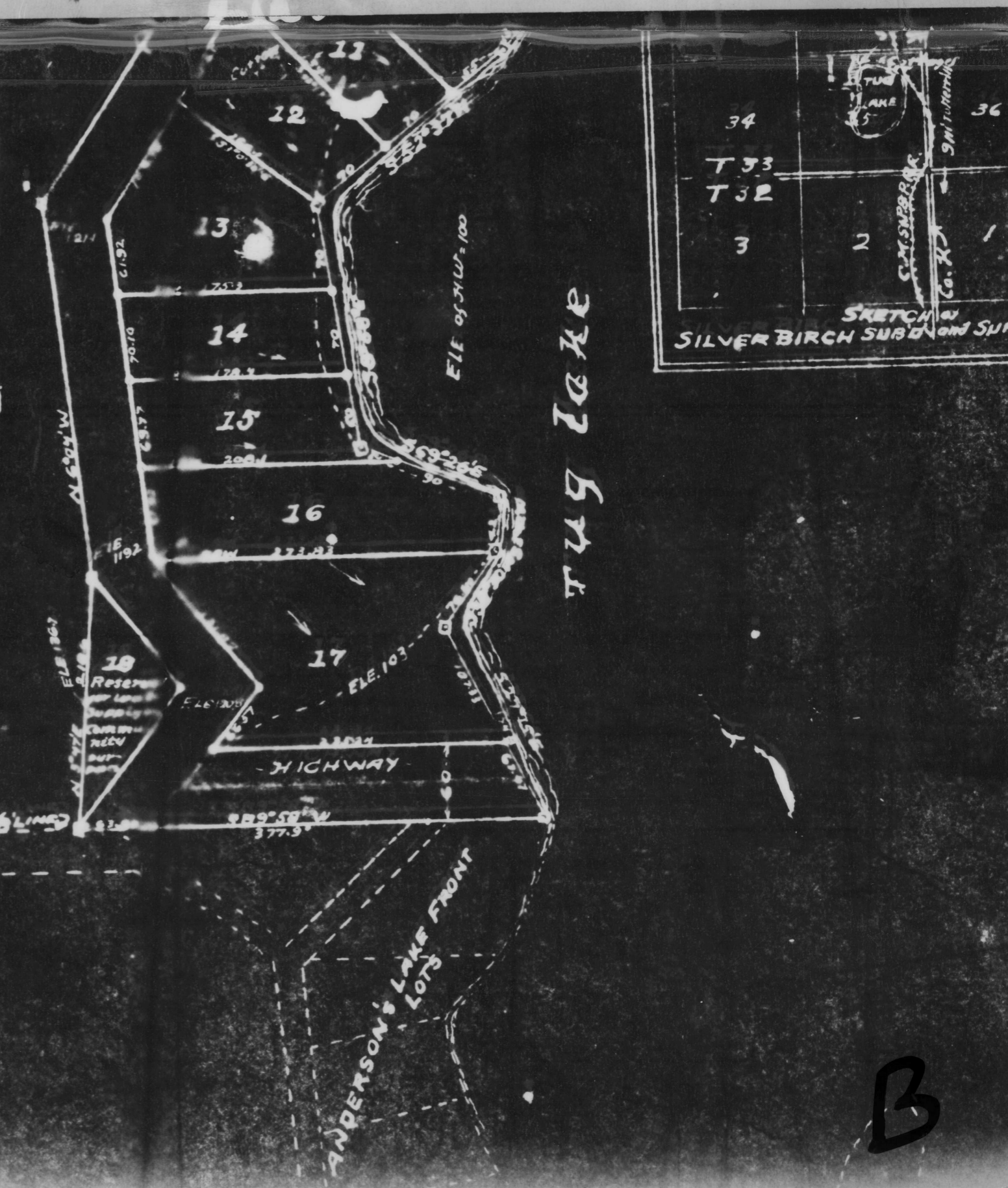
