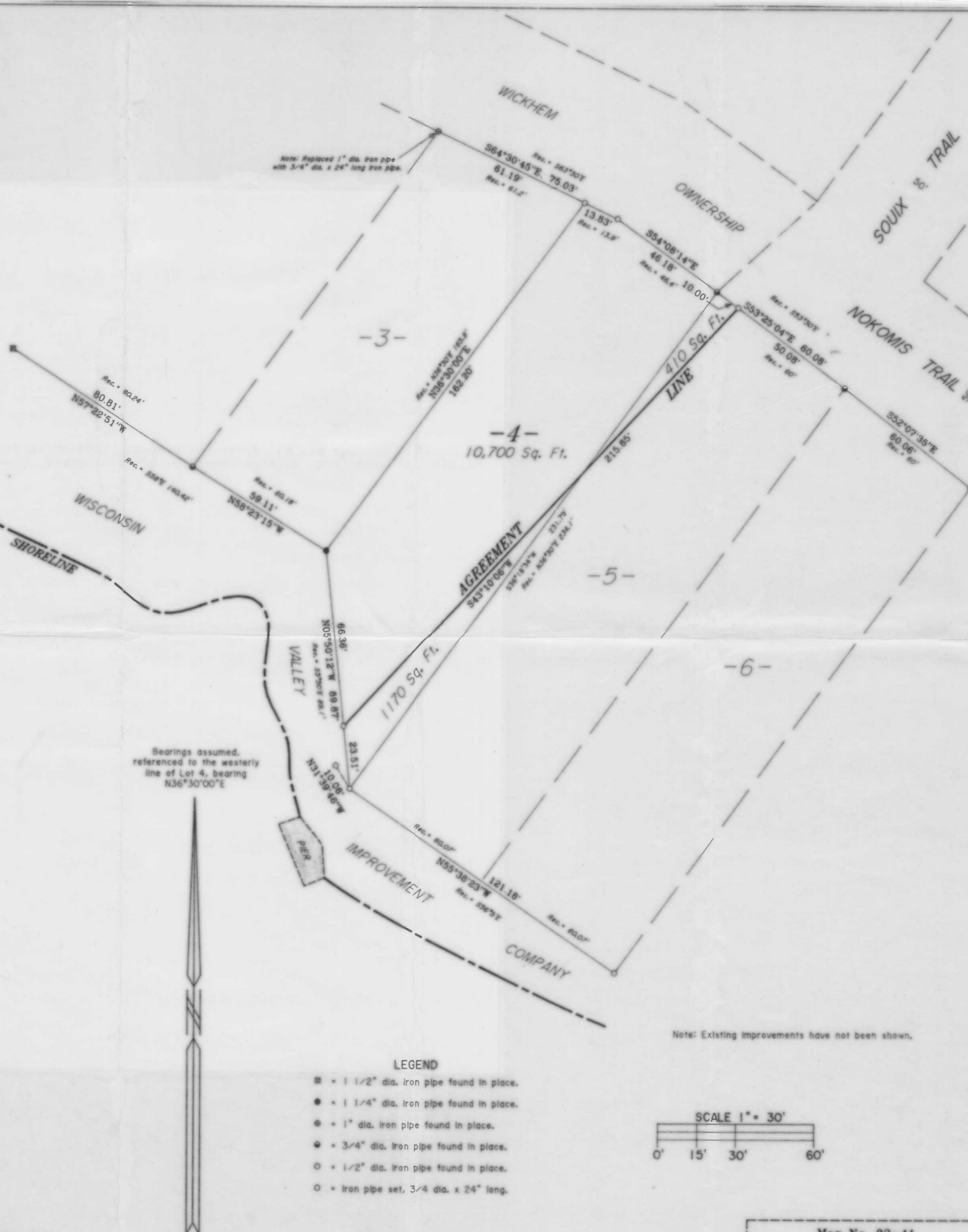

**WICKHEM TO HINZ**

All of Lot 4 of Block B in the Plat of "NOKOMIS PARK SUBDIVISION" lying east of the following described line.

An agreement line through Lots 4 and 5 of Block B, in the Plat of "NOKOMIS PARK SUBDIVISION" in Section 4, Township 35 North, Range 6 east, Bradley Township, Lincoln County, Wisconsin, being shown on Map No. 92-41 by Wilderness Surveying, Inc., dated August 13th, 1992, more particularly described as follows:

Commencing at the Northeast corner of said Lot 4, marked by an iron pipe on the southerly right of way line of Nokomis Trail, thence South 53 degrees 25 minutes 04 seconds East for a distance of 10.00 feet along the north line of said Lot 5 to the place of beginning, marked by an iron pipe.

Thence South 43 degrees 10 minutes 06 seconds West for a distance of 215.85 feet to an iron pipe on the southerly line of Lot 4 and there terminating.

All of Lot 5 of Block B in the Plat of "NOKOMIS PARK SUBDIVISION" lying west of the following described line.

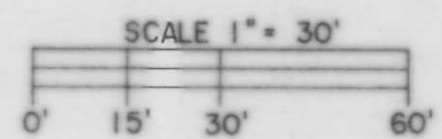

Commencing at the Northeast corner of said Lot 4, marked by an iron pipe on the southerly right of way line of Nokomis Trail, thence South 53 degrees 25 minutes 04 seconds East for a distance of 10.00 feet along the north line of said Lot 5 to the place of beginning, marked by an iron pipe.

Thence South 43 degrees 10 minutes 06 seconds West for a distance of 215.85 feet to an iron pipe on the southerly line of Lot 4 and there terminating.
