Said parcel also includes that land lying between said meander line and the normal high waterline of Long Lake, between the extension of the North and South lines of the above described lands.

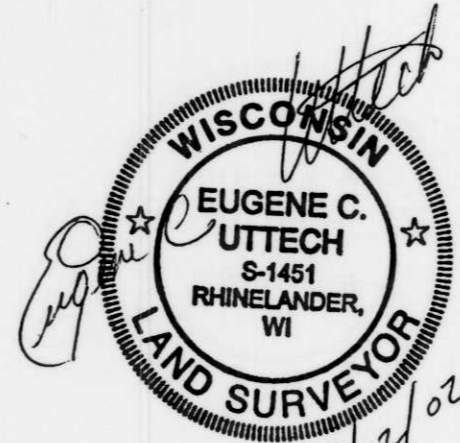

Commencing at a 6" by 6" granite monument found at the West 1/4 corner of said Section 15; thence S.89°41'00"E., along the East-West 1/4 line of said Section 15, as the same is established by 1969 Section Subdivision by William S.
