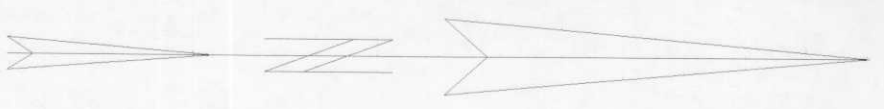

PROPERTY DESCRIPTION

A parcel of land located in the NW 1/4 - NE 1/4, Section 22, T35N, R08E, Town of Harrison, Lincoln County, Wisconsin, described as follows:

Commencing at the north 1/4 corner of said section 22; thence N88°10'39"E, a distance of 1373.64 feet to an iron pipe and point of beginning; thence S08°00'35"W, a distance of 1383.10 feet to an iron pipe on the northerly right-of-way line of County Trunk Highway "D"; thence along said right-of-way line, N89°49'57"W, a distance of 284.13 feet to a spike; thence along the arc of a curve concave to the south, having a radius of 614.24 feet and a long chord which bears S88°26'29"W 42.77 feet, a distance of 42.78 feet to an iron pipe; thence leaving said right-of-way line, N07°42'21"W, a distance of 606.85 feet to an iron pipe; thence N38°01'24"E, a distance of 975.64 feet to the point of beginning. Said parcel contains 10.00 acres. Subject to and including easements, restrictions, reservations, and right-of-ways of record or in use.

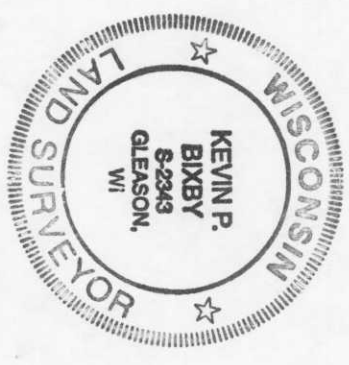

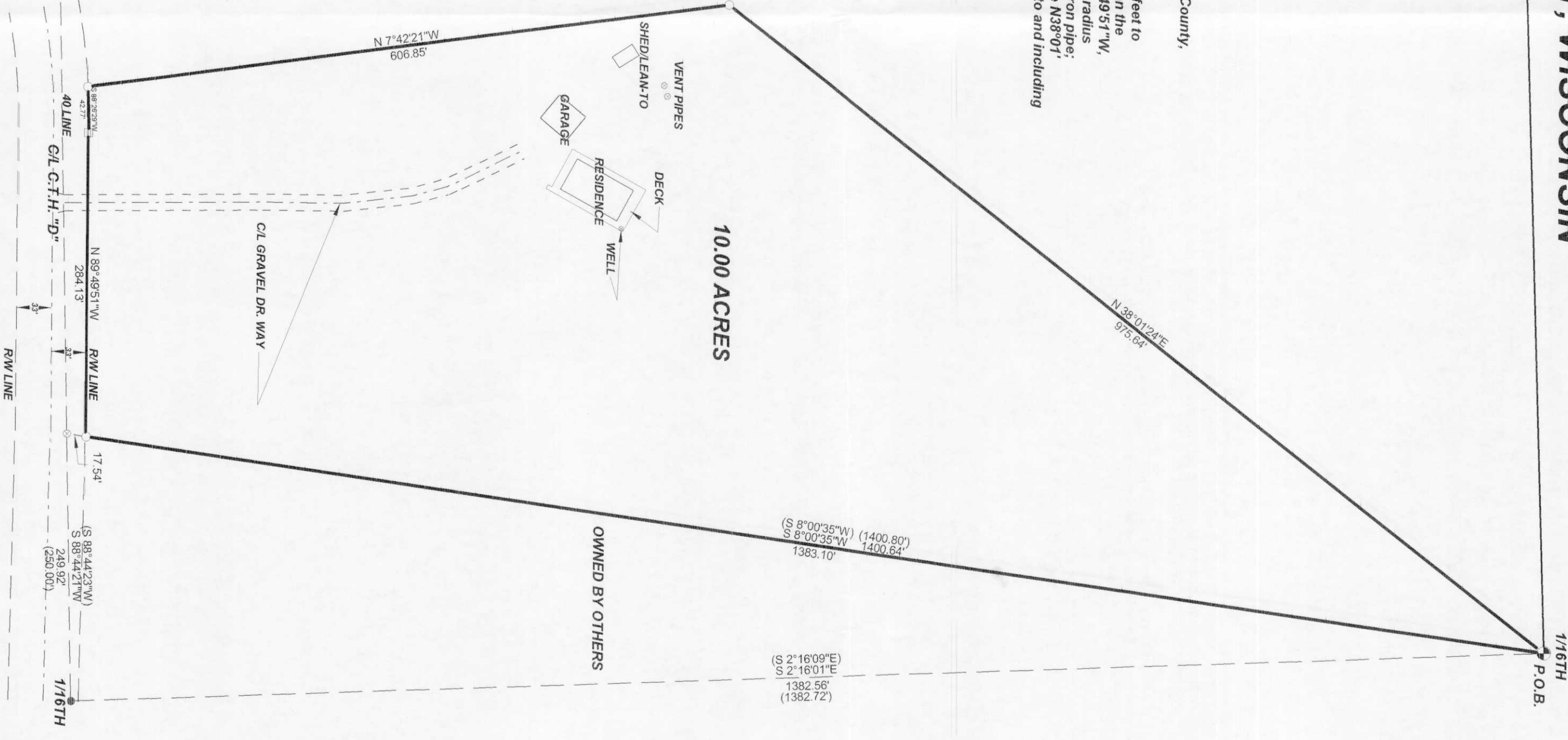
