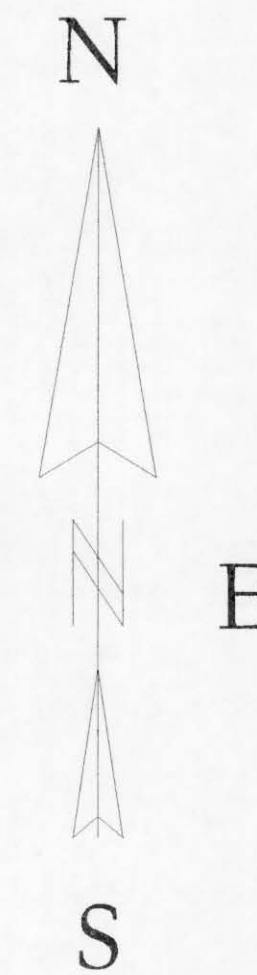
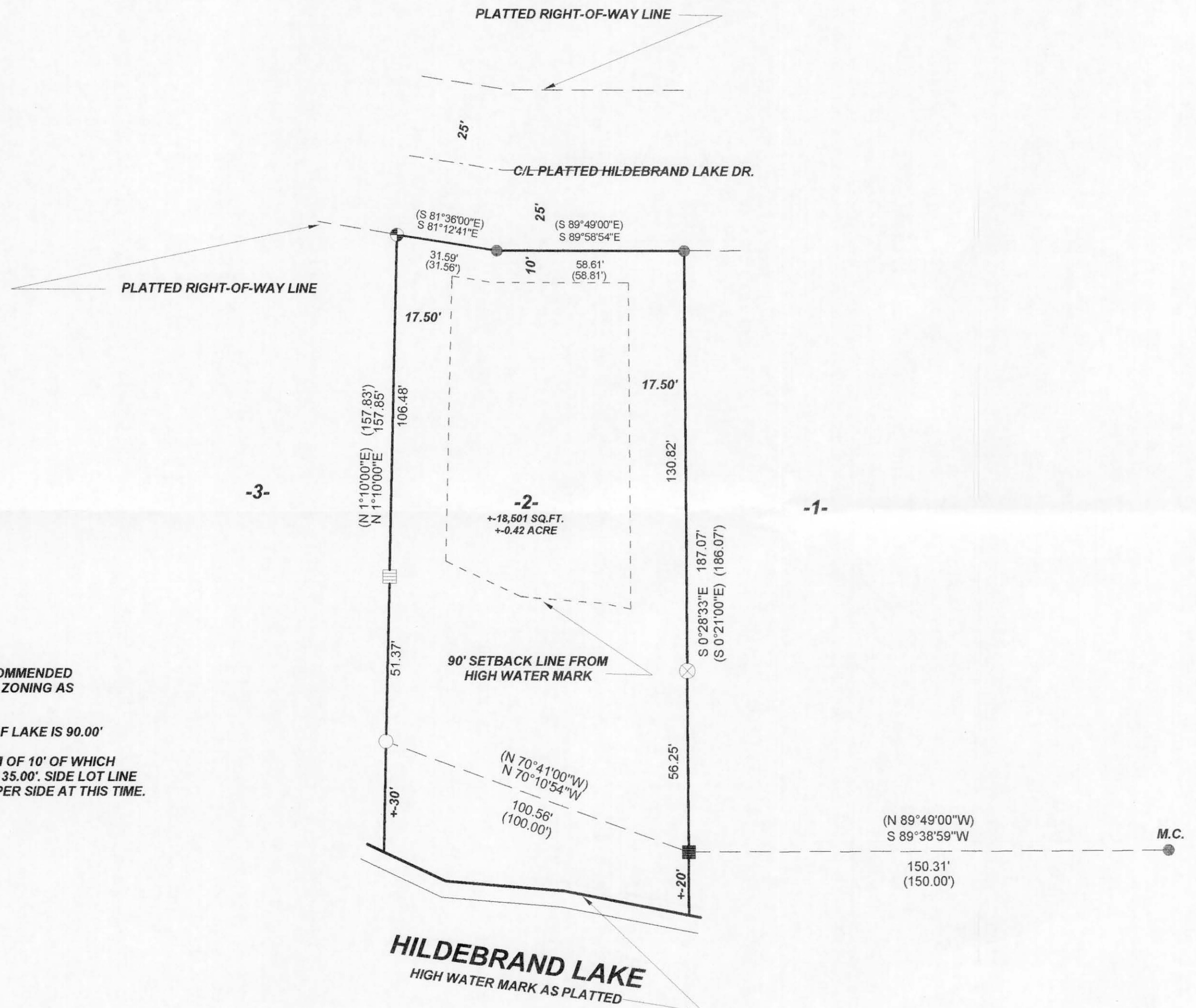


**SURVEY OF LOT 2, DEER TRAIL SHORES SUBDIVISION, LOCATED IN GOV'T.

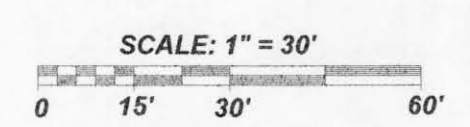
