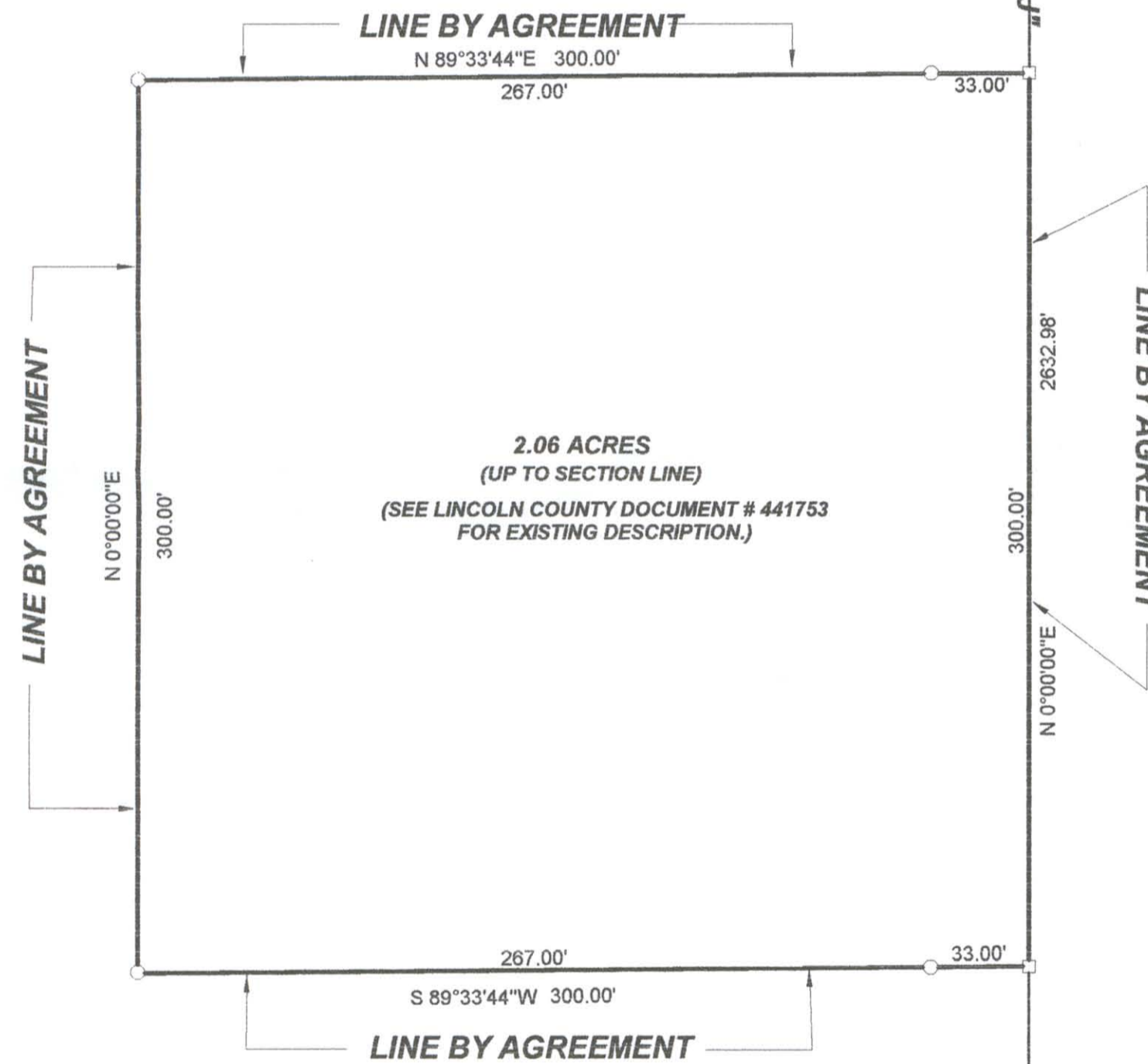

Commencing at the southeast corner of said section 24; thence N00°00'00"E, a distance of 724.09 feet to the point of beginning; thence S89°33'44"W, a distance of 300.00 feet to an iron pipe; thence N00°00'00"E, a distance of 300.00 feet to an iron pipe; thence N89°33'44"E, a distance of 300.00 feet to a point; thence S00°00'00"W, a distance of 300.00 feet to the point of beginning. Area within lines by agreement is 2.06 acres. Subject to those lands used for right-of-way purposes for County Highway "J". Subject to and including easements, restrictions, reservations, and right-of-ways of record or in use.

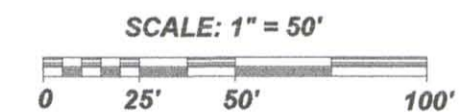


BEARINGS REF. TO THE EAST LINE SECTION 24, T33N, R07E, ASSUMED TO BEAR N00°00'00"E.

- SET 1" X 18" IRON PIPE

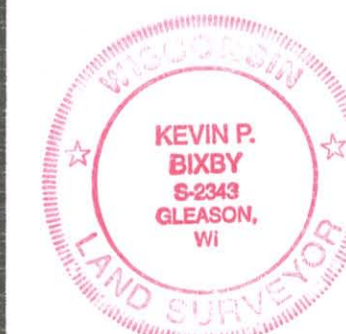
