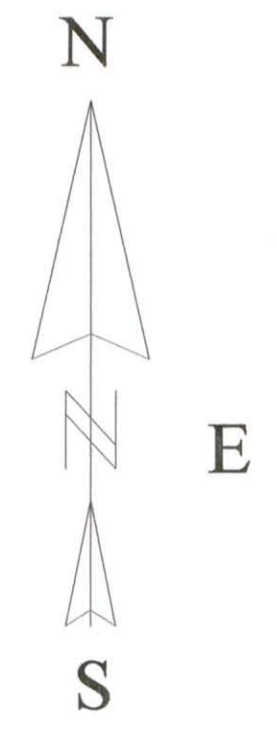

NORTH 1/4 CORNER SECTION 22 S 89°58'41"W 2678.77' NE CORNER SECTION 22



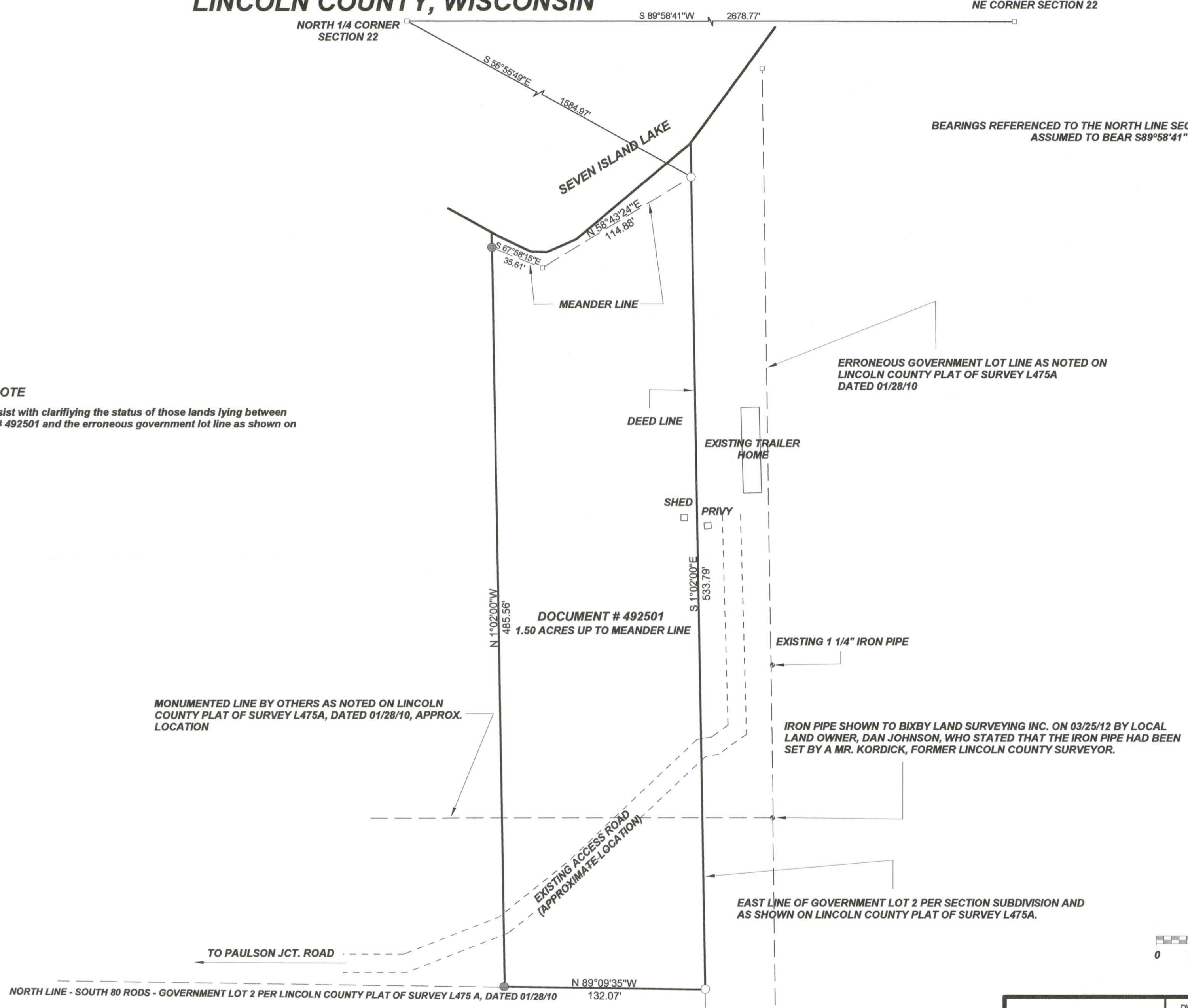
BEARINGS REFERENCED TO THE NORTH LINE SECTION 22, T34N, R08E, ASSUMED TO BEAR S89°58'41"W.

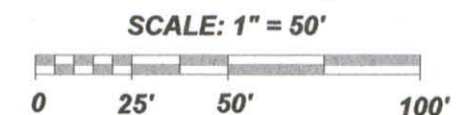
