Brzezinski Parcel (Map No. 13-29)

That parcel of land previously described in Document Number 477911, and being located in Government Lot 4, Section 2, Township 35 North, Range 6 East, Town of Bradley, Lincoln County, Wisconsin, being the "Brzezinski Parcel" shown on Map No. 13-29 by Oestreich Surveying & Mapping, LLC, dated November 20<sup>th</sup>, 2013, more accurately described as follows:

Commencing at the southeast corner of Section 2, marked by a Berntsen aluminum monument; thence N88°58'56"W 900.00 feet along the south line of Section 2 to an iron rod in the pavement of Wurl Road; thence N05°23'45"E 166.87 feet to an iron pipe near the southerly shore of Deer Lake; thence meandering along the lake N60°30'01"W 50.00 feet and N35°05'16"W 50.00 feet to the place of beginning, marked by an iron rod.

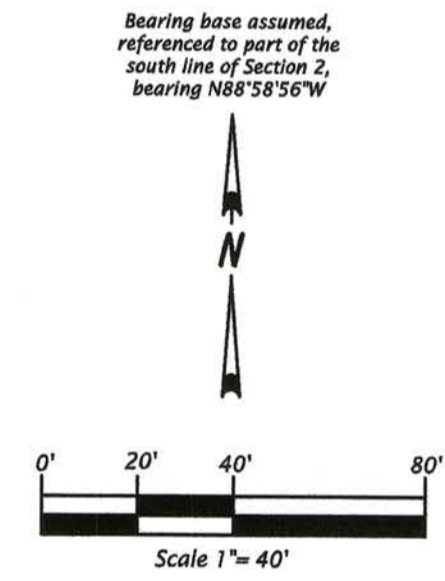
Thence continuing along the lake N23°18'39"W 90.00 feet to a 6" spike; thence S45°59'31"W 195.77 feet to an iron rod on the east side of Acorn Road; thence along the east side of Acorn Road S27°56'38"E 100.00 feet to an iron rod; thence N42°26'14"E 192.00 feet to the place of beginning.

The above lateral lot lines extend to Deer Lake, and include all lands lying between the meander line and the ordinary high water mark.

Excepting therefrom that thirty (30) foot wide strip of land described in Volume 86 of Deeds, on page 41.

Together with and subject to covenants, easements, exceptions, and restrictions of record, or of use.

Said parcel contains 18,300 square feet more or less to the shore of Deer Lake.



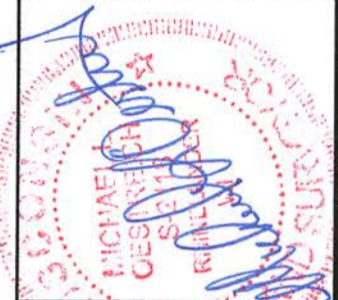
