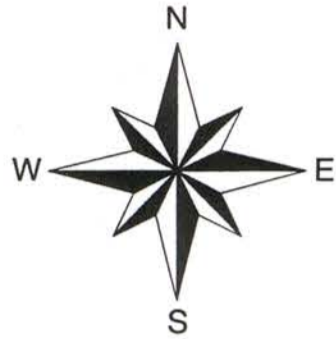
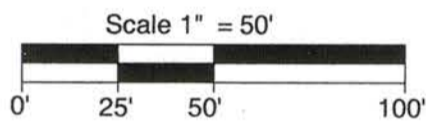

 Referenced to the Boundary Line Agreement recorded in Document No. 474122 as bearing N89°52'06"E



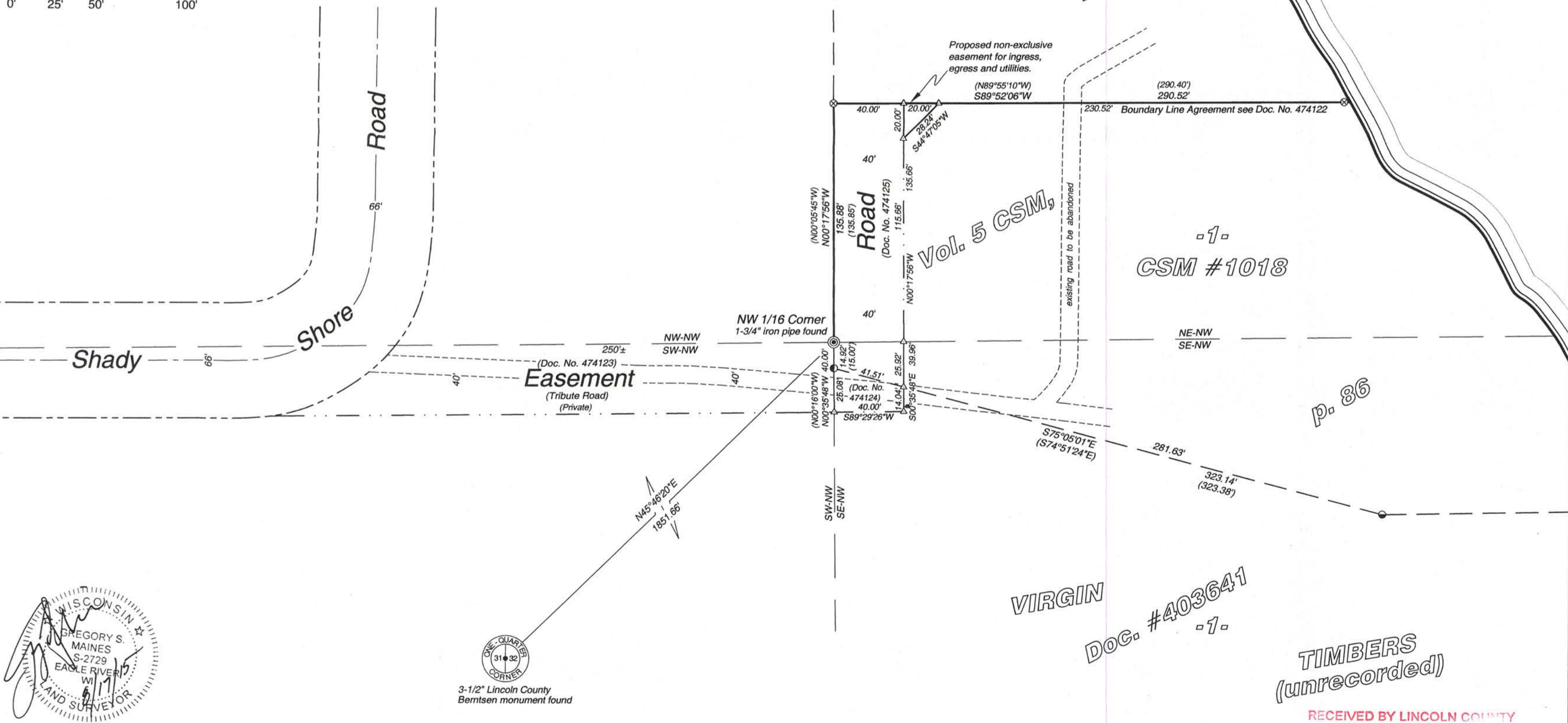
- △ Computed position

**Proposed Easement Description**

Commencing at the West 1/4 Corner of said Section 32 marked by a Lincoln County Berntsen monument; thence N45°46'20"E for a distance of 1851.66 feet to an iron pipe at the Northwest 1/16 Corner; thence along the west line of said NE 1/4 of the NW 1/4 N00°17'56"W for a distance of 135.88 feet to an iron pipe on the Boundary Line Agreement recorded in Document No. 474122; thence along said agreement line N89°52'06"E for a distance of 40.00 feet to the Northeast corner of the easement recorded in Document No. 474125, the PLACE OF BEGINNING. Thence continuing along said agreement line N89°52'06"E for a distance of 20.00 feet; thence S44°47'05"W for a distance of 28.24 feet to the east line of said easement recorded in Document No. 474125; thence along said east line N00°17'56"W for a distance of 20.00 feet to the PLACE OF BEGINNING.
