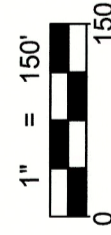
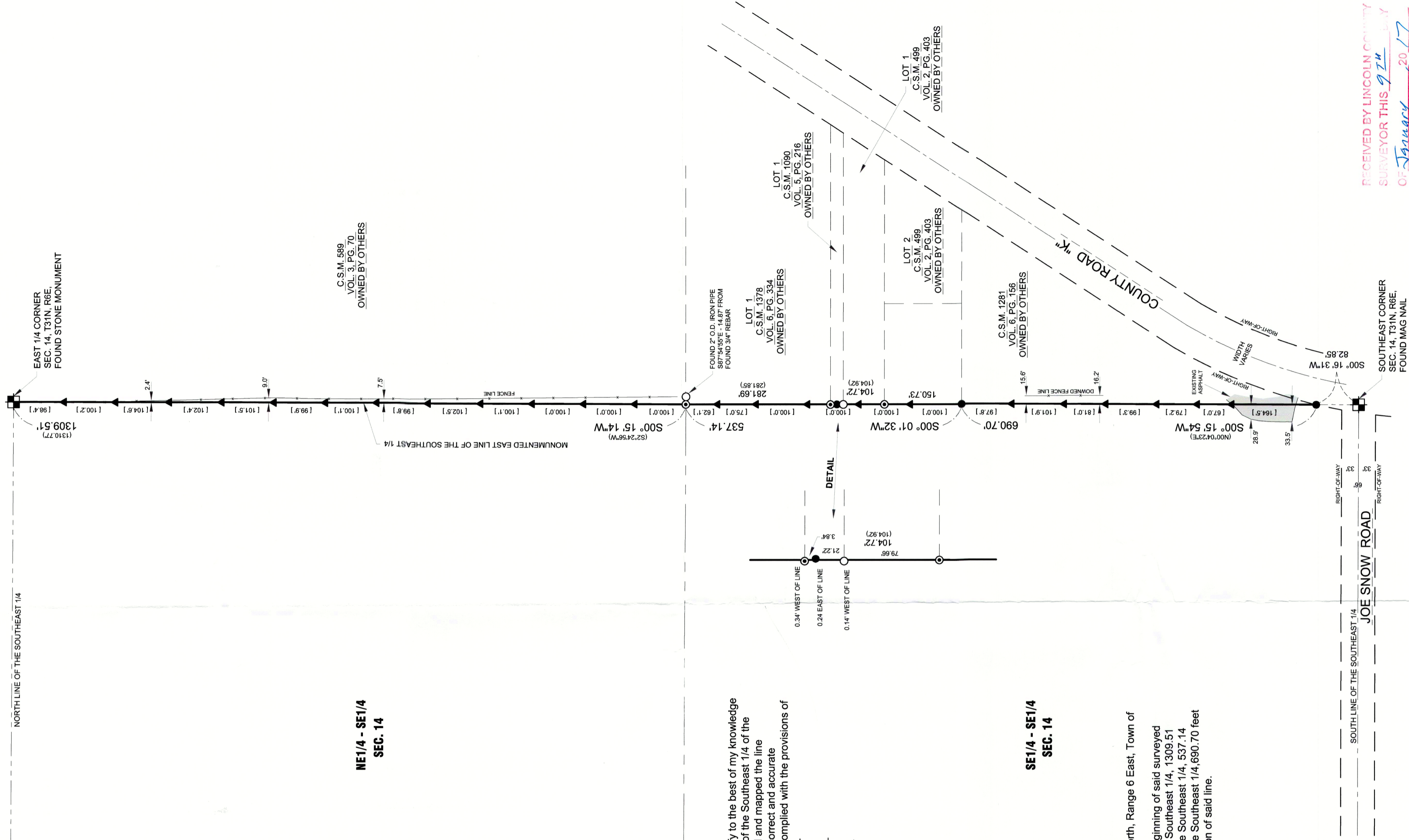


PLAT OF SURVEY

Of part of the East line of the Southeast 1/4 of Section 14, Township 31 North, Range 6 East, Town of Scott, Lincoln County, Wisconsin.



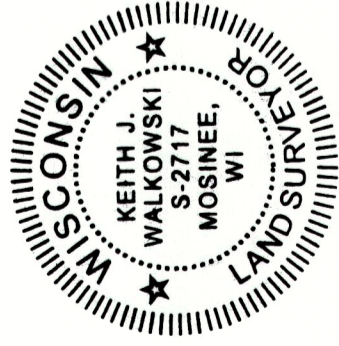
