**NOTES:**

The centerline of the abandoned railroad grade was determined by "best fit" methods of numerous location shots on the obvious center of the existing grade in Sections 25, 36 and adjoining Section 31. The Certified Survey Maps west of the Reinhardt property to not accurately represent the west line of the abandoned railroad grade.

A thorough search for original 50' road right-of-way pipes as shown on the West Alexander Lake Plat was made. Other than 2 pipes shown as 'found' on CSM #2892, no other stakes were found. The right of way of Alexander Lake Road shown on this map is based on 25' from the center of pavement.

Ownership information shown is taken from deeds noted and the Lincoln County Geographic Information mapping website.

The South line of the Charles Reinhardt Lands L.L.C. lands in the SW-SW is shown to the centerline of C.T.H. "E" as I can find no deed to the County for this portion of C.T.H. "E".
