Being a parcel of land in Gov't. Lot 3, Section 14, T34N, RoE, Bradley Township, Lincoln County, Wisconsin, more particularly described as follows:

Commencing at the 1/4 corner common to Sections 13 and 14, marked by a 2° iron pipe; thence N44-10'37"W, 1956.72 feet to a point on the easterly right-of-way of U.S. Highway "51", the place of beginning.
