Green, Registered Land Surveyor in the State of Wisconsin, hereby certify that by the order of Lawrence Krause, I have surveyed, monumented and mapped lands located in the SE $\frac{1}{4}$ of the SE $\frac{1}{4}$, the SW $\frac{1}{4}$ of the SE $\frac{1}{4}$ and the SE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 6, T.33N., R.6., Town of Rock Falls, Lincoln County, Wisconsin being more particularly described as follows:
