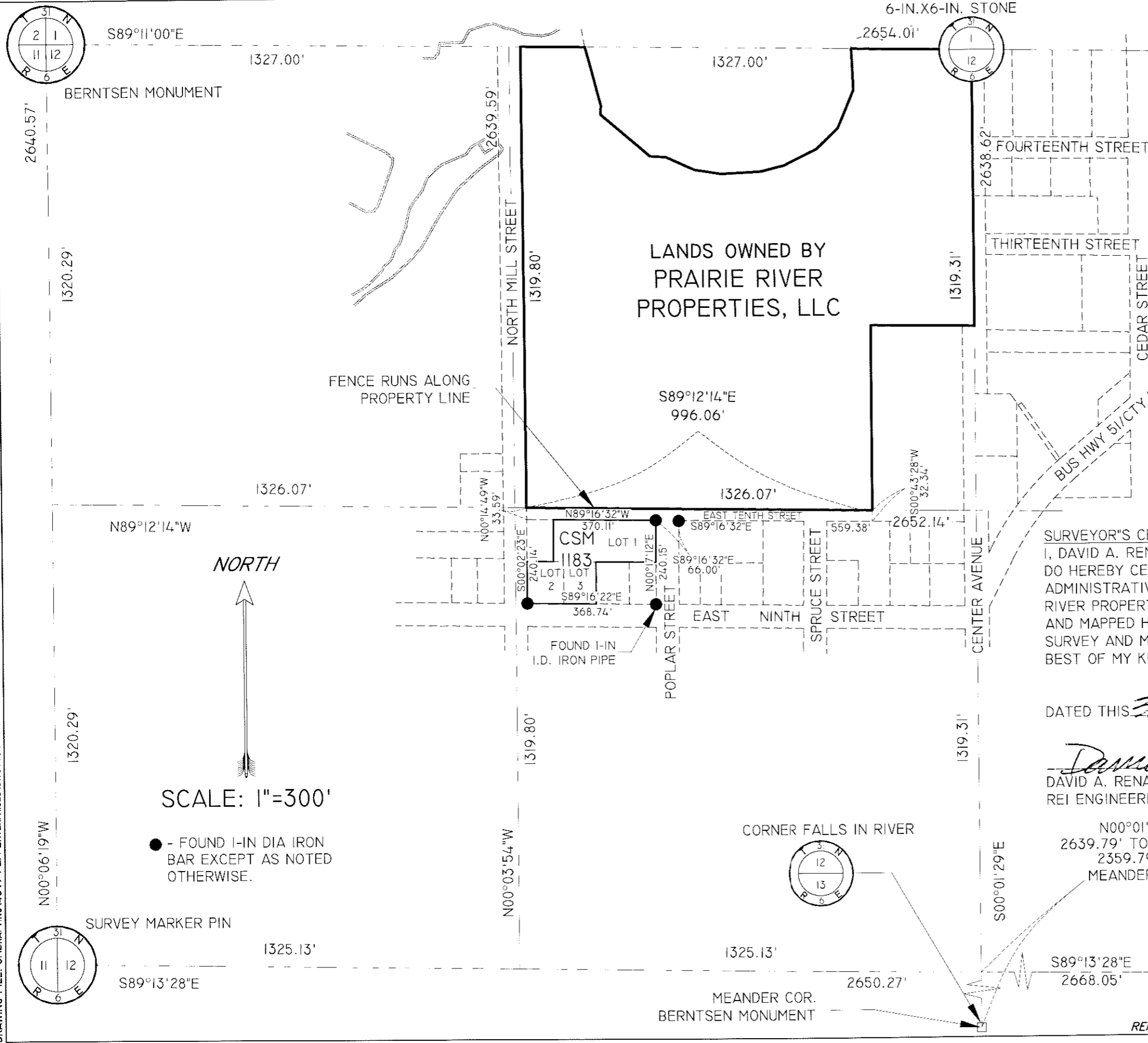

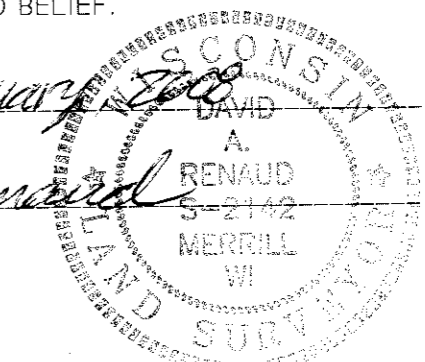
LEGAL DESCRIPTION
