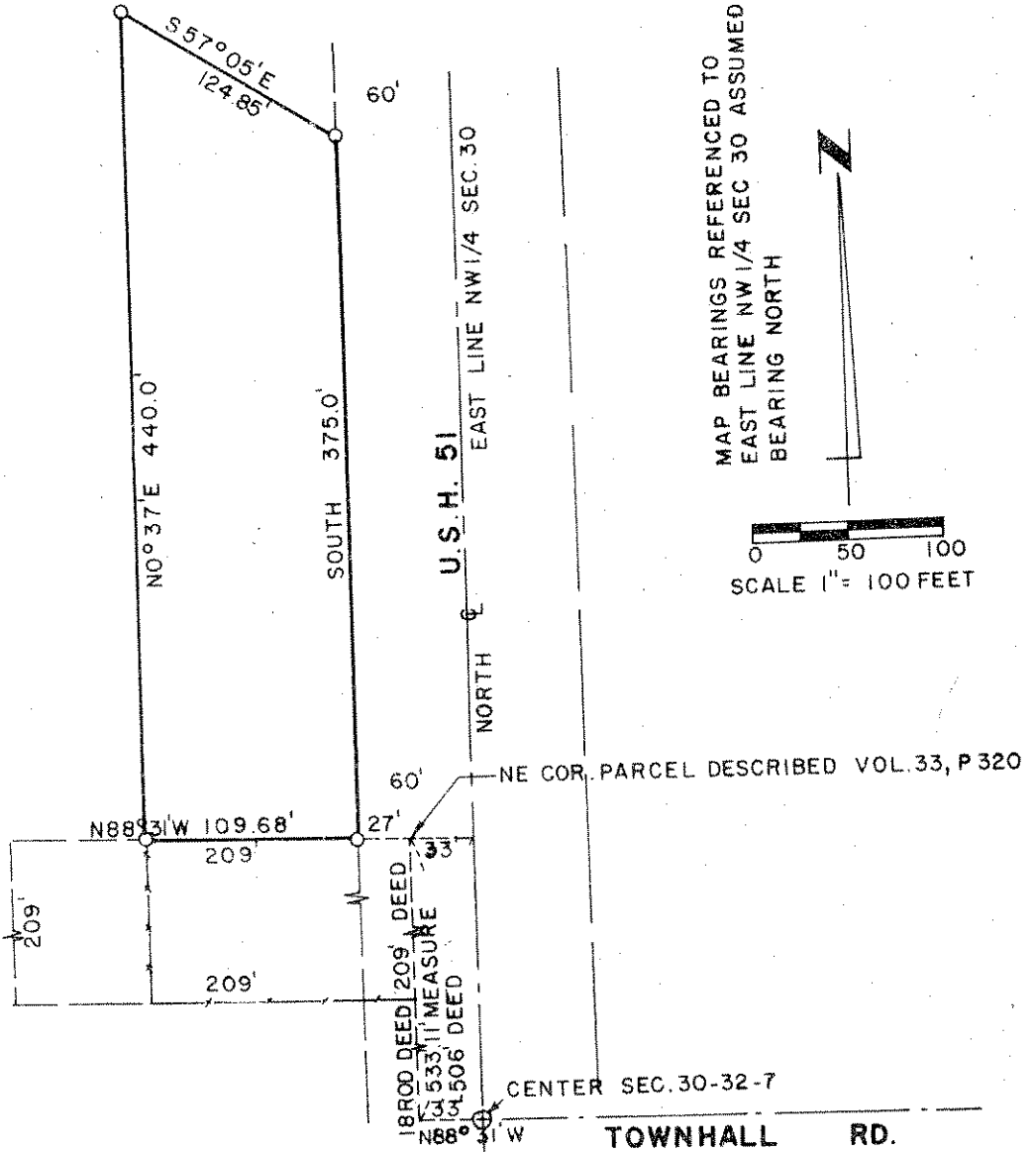
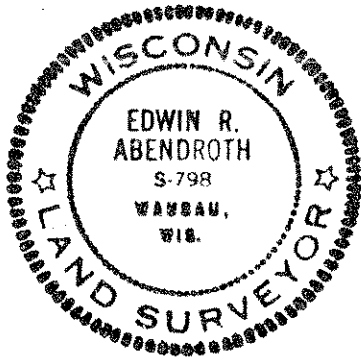


CERTIFIED SURVEY MAP

thence N88°-31'W, 33 feet, thence North, 533.11 feet, 506 feet (deed); to the

County Registry; thence continuing N88°-31'W, 27 feet to the west line of  
U.S.H. 51; thence continuing N88°-31'W on the north line of said lands


