NOTES:

1. The unrecorded plat of "Thieler's Squaw Lake Subdivision" was not accurately surveyed, accurately platted or adequately monumented. Also Hilts Lake Road was not built in the location shown on the plat. The unresolvable problems with "Thieler's Squaw Lake Subdivision" is further documented in 1979-1980 as noted on maps "L59B" and "L59C" of Lincoln County Surveyor's Records. Due to this fact the lot lines of said plat were not able to be determined and, along with the location of existing improvements, resulted in the "Line by Agreement" shown.
2. The deflection in the this line was made to include an existing outhouse and yard area of the Sliwicki property.
3. Legal descriptions were provided to the client on separate sheets.

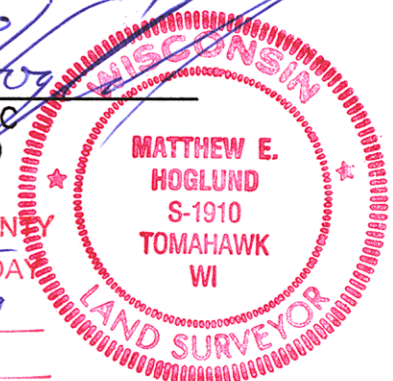

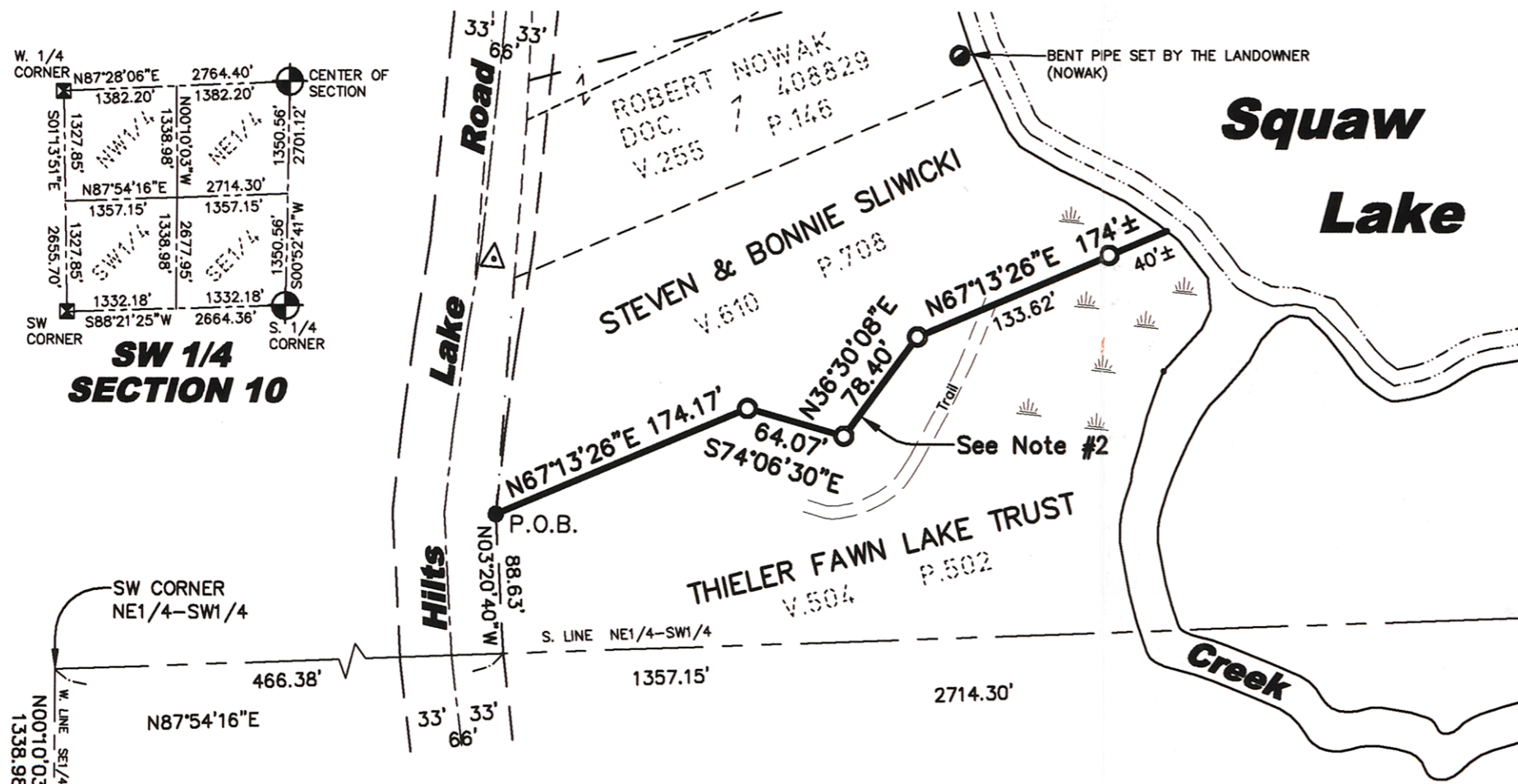
