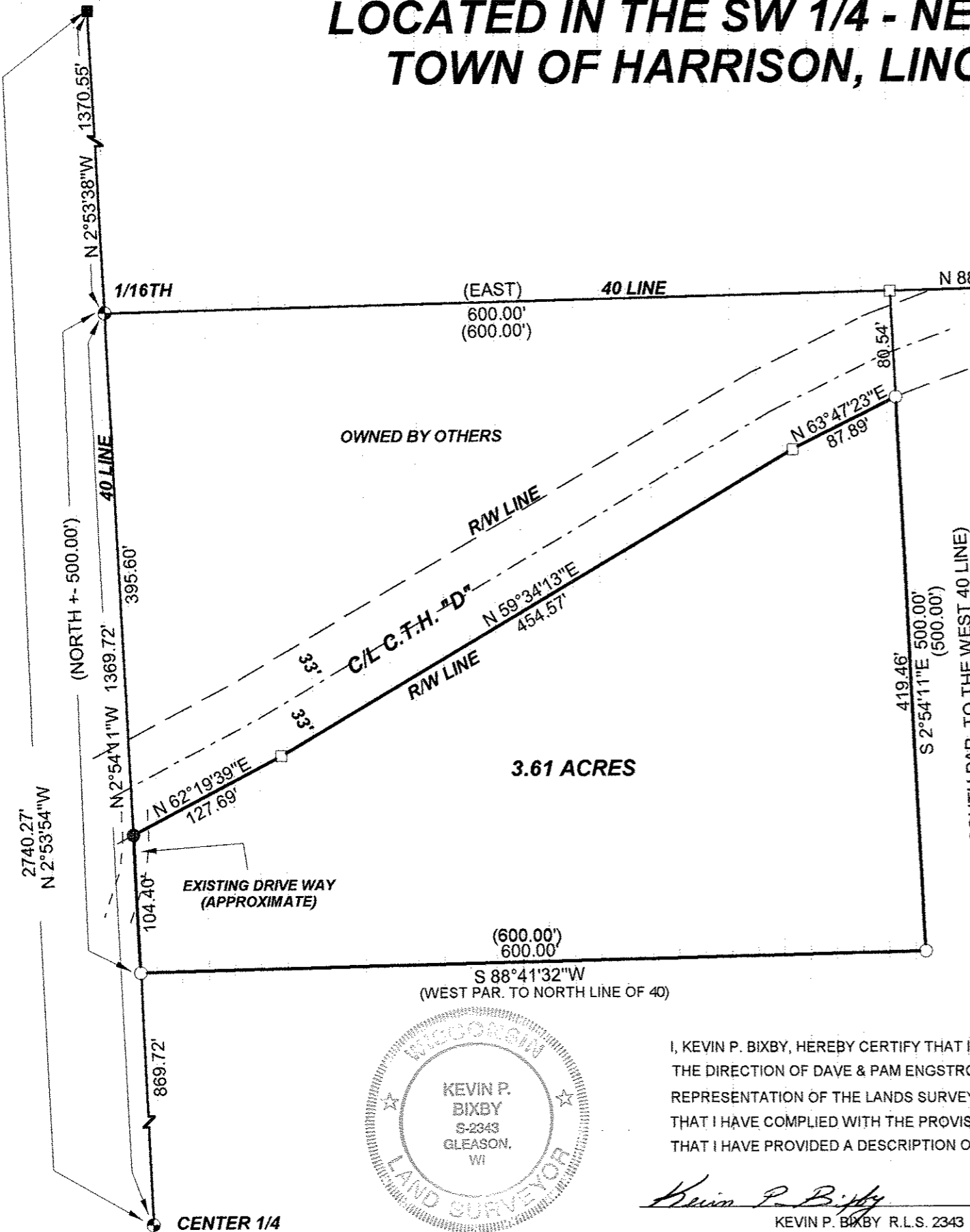
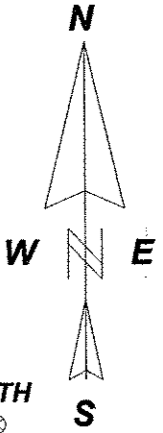


NORTH 1/4 SECTION 22

PROPERTY DESCRIPTION

A parcel of land located in The SW 1/4 - NE 1/4, Section 22, T35N, R08E,
Town Of Harrison, Lincoln County, Wisconsin described as follows:

Commencing at the North 1/4 corner of said section 22; thence S02°53'38"E, a distance of 1370.55 feet to an iron pipe; thence S02°54'11"E, a distance of 395.60 feet to an iron pipe on the southerly right-of-way line of County Trunk Highway "D" and point of beginning; thence along said right-of-way line, N62°19'39"E, a distance of 127.69 feet to a point; thence N59°34'13"E, a distance of 454.57 feet to a point; thence N63°47'23"E, a distance of 87.89 feet to an iron pipe; thence leaving said right-of-way line, S02°54'11"E, a distance of 419.46 feet to an iron pipe; thence S88°41'32"W, a distance of 600.00 feet to an iron pipe; thence N02°54'11"W, a distance of 104.40 feet to the point of beginning. Said parcel contains 3.61 acres. Subject to and including easements, restrictions, reservations, and right-of-ways of record or in use.
