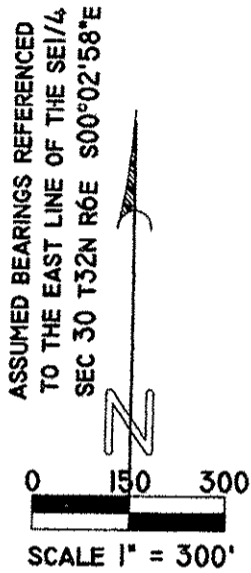
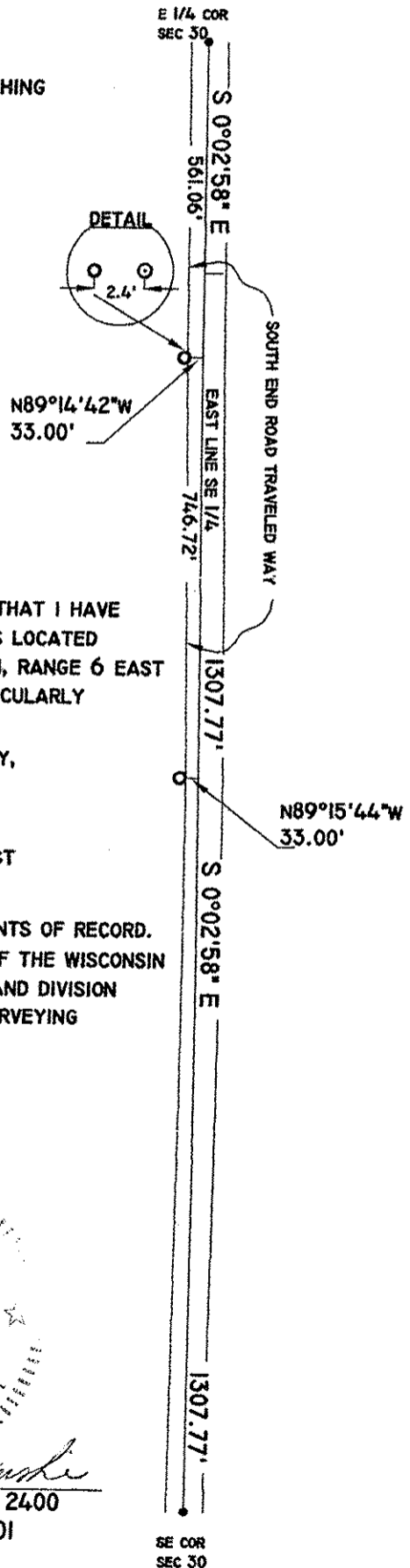


PART OF THE NE1/4 OF THE SE1/4 OF SEC. 30,

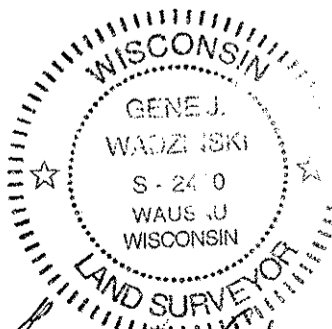
