

LINCOLN COUNTY CERTIFIED SURVEY MAP

I, David L. Osterbrink, Registered Land Surveyor, hereby certify that I have surveyed and mapped by the order of Harvey Woodward, that part of Government Lot 3, and 4, Section 18, Township 31 North, Range 7 East, Town of Pine River, Lincoln County, Wisconsin, described as follows: Commencing at the Northeast corner of said Section 18; thence S0°58'41"E along the East line of the Northeast 1/4 of Section 18, 1326.40 feet to the Northeast corner of Government Lot 4; thence S85°43'43"W along the North line of Government Lot 4, 751.41 feet to the Easterly right-of-way of the Wisconsin Central Ltd. Rail Road, and the point of beginning; thence S60°14'21"E, 209.66 feet; thence S35°39'35"E, 129.27 feet to the Northerly right-of-way of Bluebird Lane; thence N56°21'44"E along said right-of-way, 239.39 feet to the Westerly right-of-way of Big Eddy Road; thence N38°05'28"W along said right-of-way, 45.12 feet; thence N39°15'48"W along the Westerly right-of-way of Big Eddy Road, 556.75 feet; thence N39°48'24"W along said right-of-way, 457.60 feet to a point of curvature; thence along the arc of a curve whose long chord bears N41°08'01"W, a distance of 96.98 feet; thence leaving the right-of-way of Big Eddy Road, S47°32'21"W, 0.77 feet to the Easterly right-of-way of the Wisconsin Central LTD. Rail Road; thence along said right-of-way along the arc of a curve whose long chord bears S23°54'50"E, 639.65 feet to a point of tangency; thence continuing along said right-of-way, S5°22'06"E, 230.40 to the point of beginning.

Along with an easement for perpetual ingress and egress to Lot 1 of Certified Survey Map recorded in Volume 3, Page 160, in the Lincoln County Register of Deeds Office, described as follows: Commencing at the Northeast corner of said Section 18; thence S0°58'41"E along the East line of the Northeast 1/4 of Section 18, 1326.40 feet to the Northeast corner of Government Lot 4; thence S85°43'43"W along the North line of Government Lot 4, 751.41 feet to the Easterly right-of-way of the Wisconsin Central Ltd. Rail Road, thence S60°14'21"E, 209.66 feet to the point of beginning; thence N49°05'45"E, 231.13 feet to the Southwesterly right-of-way of Big Eddy Road; thence N39°15'48"W along said right-of-way, 33.01 feet; thence S49°05'45"W, 243.66 feet to the Southerly line of Lot 3; thence S60°14'21"E along said line, 34.97 feet to the point of beginning. Described easement is 33 feet wide.

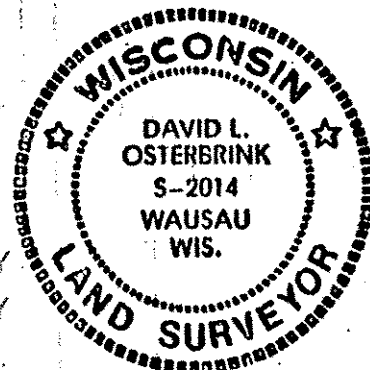
Subject to easements and roadways of record.
