A parcel of land in Government Lot 3, Section 16, Township 35 North, Range 7 East, King Township, Lincoln County, Wisconsin, being “-ROAD SEGMENT -A-“ shown on Map No. 99-125R by Wilderness Surveying, Inc., dated January 10th, 2000, and revised February 14th, 2000, more particularly described as follows:

Commencing at the north quarter corner of Section 16, marked by a P.K. nail; thence South 00 degrees 04 minutes 01 seconds East for a distance of 2630.24 feet to the Center-Quarter, marked by an iron pipe; thence South 00 degrees 03 minutes 17 seconds East for a distance of 1316.01 feet to the Center-South Sixteenth Corner, marked by and iron pipe; thence South 89 degrees 45 minutes 06 seconds East for a distance of 87.99 feet to the place of beginning, marked by an iron pipe.

Thence continuing South 89 degrees 45 minutes 06 seconds East for a distance of 11.12 feet to an iron pipe; thence along a curve to the right, having a radius of 60.00 feet and an arc length of 164.14 feet, being subtended by a chord of South 04 degrees 35 minutes 03 seconds West for a distance of 117.54 feet to an iron pipe; thence North 00 degrees 50 minutes 36 seconds West for a distance of 117.22 feet to the place of beginning.

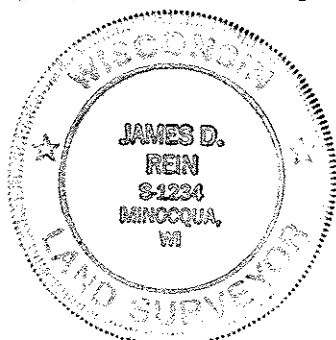

Commencing at the north quarter corner of Section 16, marked by a P.K. nail; thence South 00 degrees 04 minutes 01 seconds East for a distance of 2630.24 feet to the Center-Quarter, marked by an iron pipe; thence South 00 degrees 03 minutes 17 seconds East for a distance of 1316.01 feet to the Center-South Sixteenth Corner, marked by and iron pipe; thence South 89 degrees 45 minutes 06 seconds East for a distance of 66.10 feet to the place of beginning, marked by an iron pipe.

Thence continuing South 89 degrees 45 minutes 06 seconds East for a distance of 21.89 feet to an iron pipe; thence South 00 degrees 50 minutes 36 seconds East for a distance of 147.74 feet to an iron pipe; thence along a curve to the right, having a radius of 75.00 feet and an arc length of 227.19 feet, being subtended by a chord of North 09 degrees 14 minutes 42.5 seconds West for a distance of 149.76 feet to the place of beginning.
