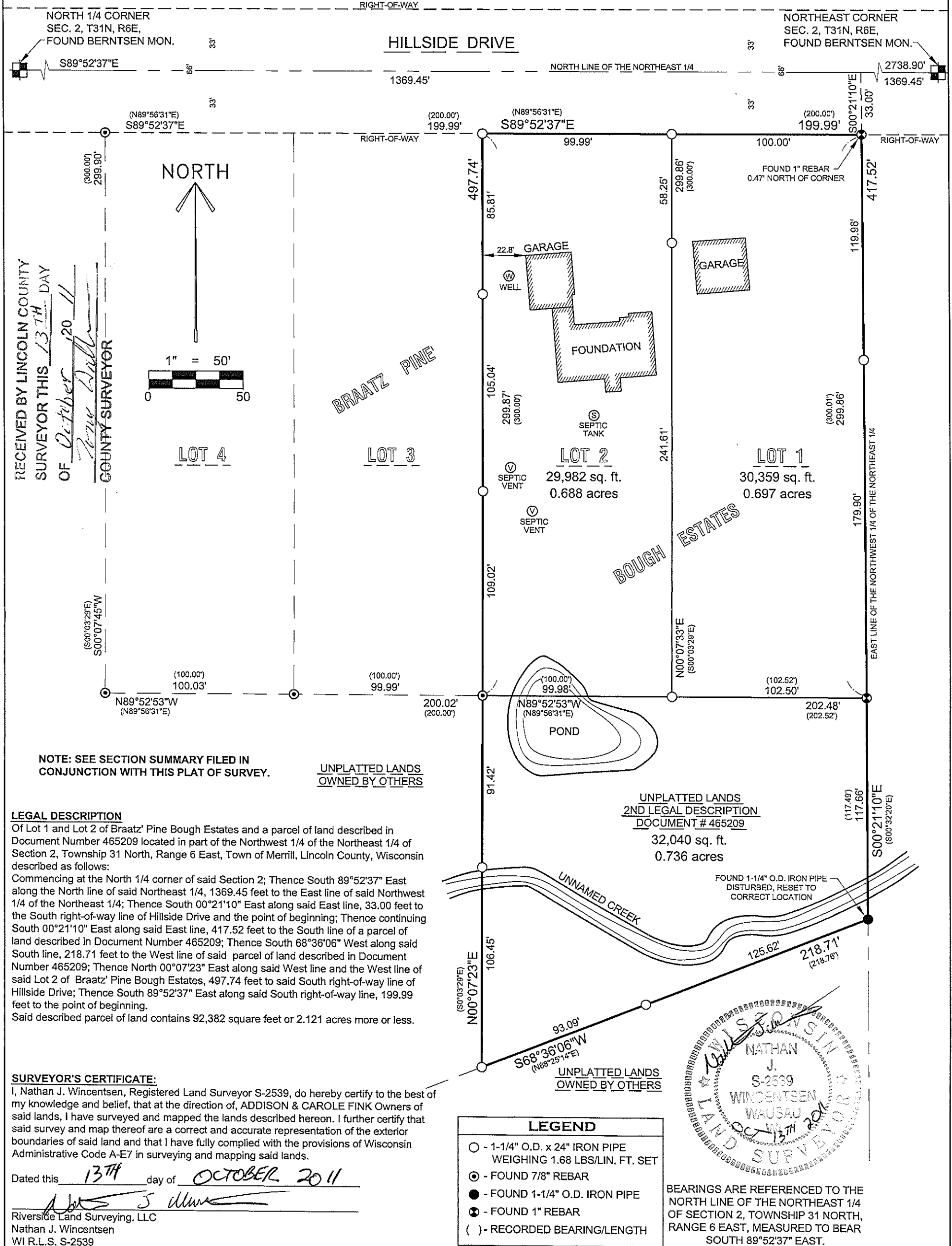


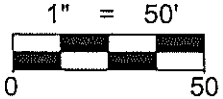

Of Lot 1 and Lot 2 of Braatz' Pine Bough Estates and a parcel of land described in Document Number 465209 located in part of the Northwest 1/4 of the Northeast 1/4 of Section 2, Township 31 North, Range 6 East, Town of Merrill, Lincoln County, Wisconsin described as follows:

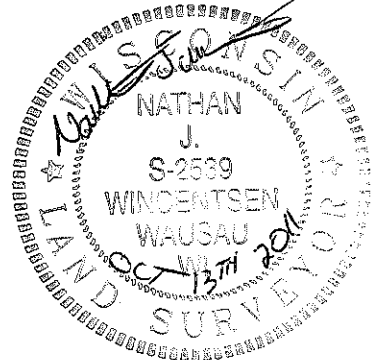
Commencing at the North 1/4 corner of said Section 2; Thence South 89°52'37" East along the North line of said Northeast 1/4, 1369.45 feet to the East line of said Northwest 1/4 of the Northeast 1/4; Thence South 00°21'10" East along said East line, 33.00 feet to the South right-of-way line of Hillside Drive and the point of beginning; Thence continuing South 00°21'10" East along said East line, 417.52 feet to the South line of a parcel of land described in Document Number 465209; Thence South 68°36'06" West along said South line, 218.71 feet to the West line of said parcel of land described in Document Number 465209; Thence North 00°07'23" East along said West line and the West line of said Lot 2 of Braatz' Pine Bough Estates, 497.74 feet to said South right-of-way line of Hillside Drive; Thence South 89°52'37" East along said South right-of-way line, 199.99 feet to the point of beginning.
