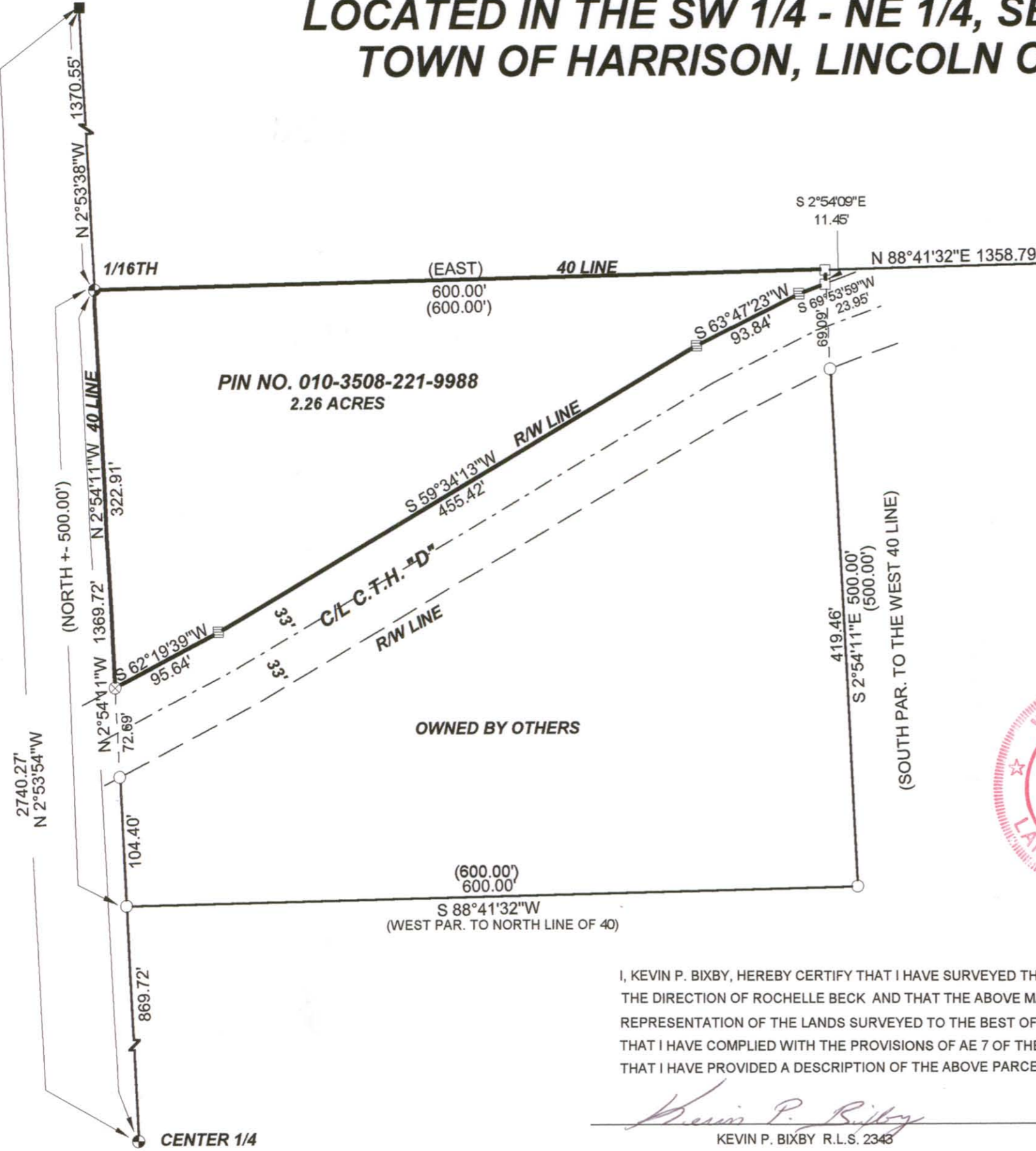


NORTH 1/4 SECTION 22

PROPERTY DESCRIPTION
A parcel of land located in The SW 1/4 - NE 1/4, Section 22, T35N, R08E,
Town Of Harrison, Lincoln County, Wisconsin described as follows:

Commencing at the north 1/4 corner of said section 22; thence S02°53'38"E,
a distance of 1370.55 feet to an iron pipe and point of beginning; thence N88°
41'32"E, distance of 600.00 feet to a railroad spike; thence S02°54'09"E, a
distance of 11.45 feet to a railroad spike on the northerly right-of-way line of
County Highway "D"; thence along said right-of-way line, S69°53'59"W, a
distance of 23.95 feet to a point, thence S63°47'23"W, a distance of 93.84 feet
to a point; thence S59°34'13"W, a distance of 455.42 feet to a point; thence
S62°19'39"W, a distance of 95.64 feet to an iron pipe; thence leaving said
right-of-way line, N02°54'11"W, a distance of 322.91 feet to the point
of beginning. Said parcel contains 2.26 acres. Subject to and including easements,
restrictions, reservations and right-of-ways of record or in use.
