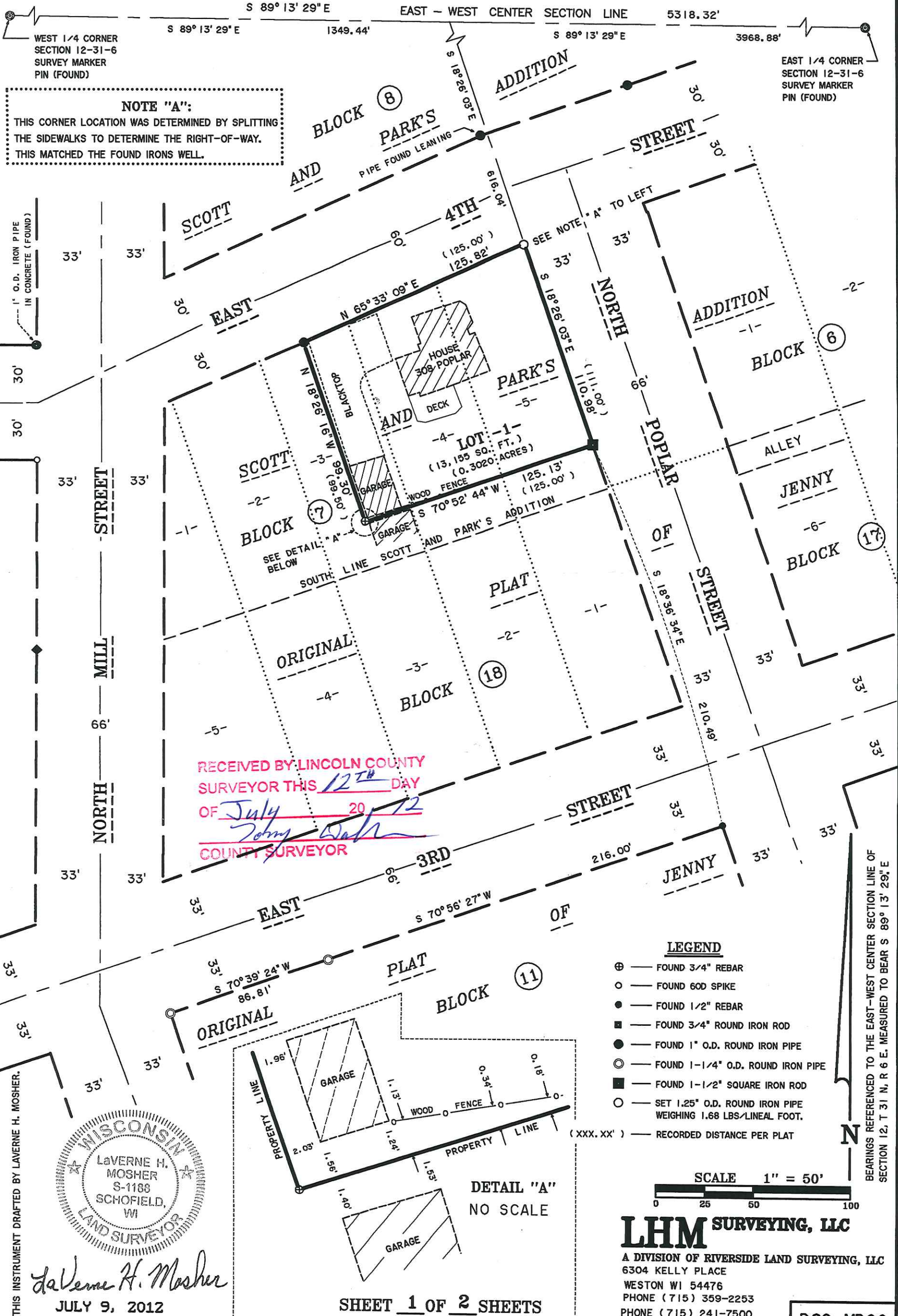


LINCOLN COUNTY PLAT OF SURVEY

LINCOLN COUNTY PLAT OF SURVEY MAP

I, LaVerne H. Mosher, Registered Land Surveyor, hereby certify:
That I have surveyed and mapped Lots 4 and 5 and the East 1/2 of Lot 3, excepting the South 17 feet thereof; all in Block 7 of Scott and Park's Addition; located in the Northeast 1/4 of the Southwest 1/4 of Section 12, Township 31 North, Range 6 East, City of Merrill, Lincoln County, Wisconsin; described as follows:

Commencing at the West 1/4 corner of said Section 12, Township 31 North, Range 6 East; thence S 89° 13' 29" E along the East-West Center Section line of said Section 12, 1349.44 feet; thence S 18° 26' 03" E, 616.04 feet to the Northeast corner of said Lot 5, Block 7 of Scott and Park's Addition; said point also being the point of beginning of the parcel to be described; thence continuing S 18° 26' 03" E along the East line of said Lot 5, 110.98 feet; thence S 70° 52' 44" W, 125.13 feet to a point on the West line of the East 1/2 of Lot 3, Block 7 of Scott and Park's Addition; thence N 18° 26' 16" W along the West line of the said East 1/2 of Lot 3, 99.30 feet to a point on the South right-of-way line of East 4th Street; thence N 65° 33' 09" E along the said South right-of-way line of East 4th Street, 125.82 feet to the point of beginning. Parcel so described contains 13,155 square feet or 0.3020 acres, more or less.

That I have made such survey and plat by the direction of Shane Demoss.

That such plat is a correct representation of all exterior boundaries of the land surveyed and the subdivision thereof made.

That I have fully complied with the provisions of Chapter A-E 7 of the Wisconsin Administrative Code and the Subdivision Regulations of Lincoln County and the City of Merrill in surveying and mapping the same.
