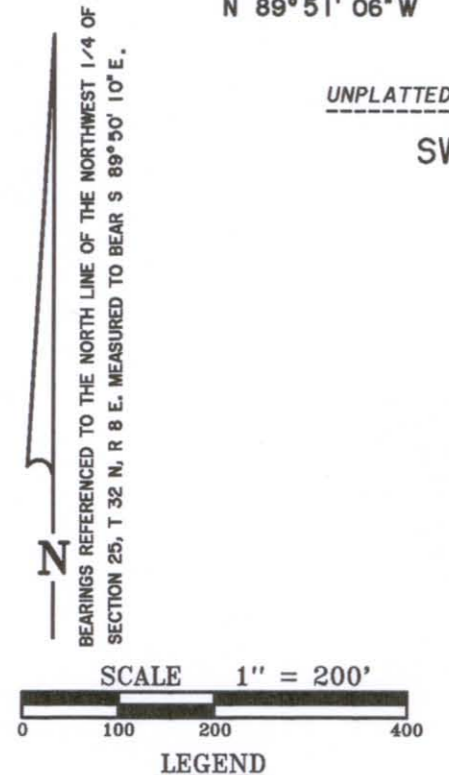
SURVEYOR'S CERTIFICATE/LEGAL DESCRIPTION

I, LAVERNE H. MOSHER, REGISTERED LAND SURVEYOR, HEREBY CERTIFY: THAT I HAVE SURVEYED AND MAPPED THE NORTHWEST 1/4 OF THE NORTHWEST 1/4 OF SECTION 25, TOWNSHIP 32 NORTH, RANGE 8 EAST, TOWN OF SCHLEY, LINCOLN COUNTY, WISCONSIN, DESCRIBED AS FOLLOWS: BEGINNING AT THE NORTHWEST CORNER OF SAID SECTION 25, TOWNSHIP 32 NORTH, RANGE 8 EAST, THENCE S 89°50'10"E ALONG THE NORTH LINE OF THE SAID NORTHWEST 1/4 OF THE NORTHWEST 1/4, 1322.50 FEET TO THE NORTHEAST CORNER OF SAID NORTHWEST 1/4 OF THE NORTHWEST 1/4; THENCE S 00°04'50"W ALONG THE EAST LINE OF THE SAID NORTHWEST 1/4 OF THE NORTHWEST 1/4; 1320.72 FEET TO THE SOUTHEAST CORNER OF THE SAID NORTHWEST 1/4 OF THE NORTHWEST 1/4; THENCE N 89°51'06"W ALONG THE SOUTH LINE OF THE SAID NORTHWEST 1/4 OF THE NORTHWEST 1/4, 1321.49 FEET TO THE SOUTHWEST CORNER OF THE SAID NORTHWEST 1/4 OF THE NORTHWEST 1/4; THENCE N 00°02'13"E ALONG THE WEST LINE OF THE SAID NORTHWEST 1/4 OF THE NORTHWEST 1/4, 1321.08 FEET TO THE POINT OF BEGINNING.
