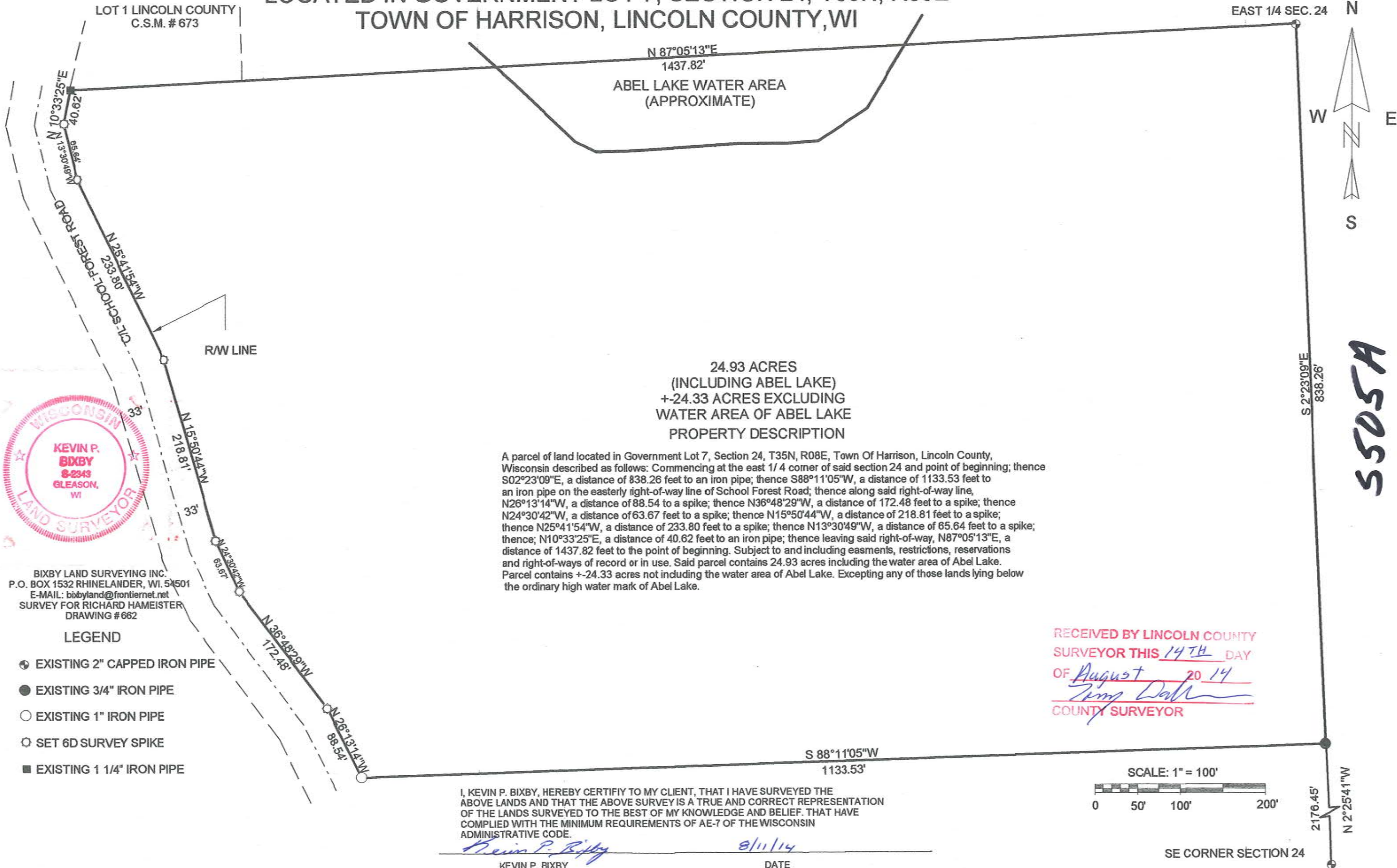


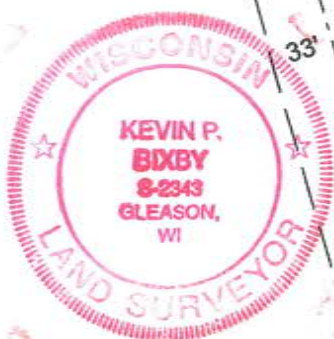

PROPERTY DESCRIPTION

A parcel of land located in Government Lot 7, Section 24, T35N, R08E, Town Of Harrison, Lincoln County, Wisconsin described as follows: Commencing at the east 1/4 corner of said section 24 and point of beginning; thence S02°23'09"E, a distance of 838.26 feet to an iron pipe; thence S88°11'05"W, a distance of 1133.53 feet to an iron pipe on the easterly right-of-way line of School Forest Road; thence along said right-of-way line, N26°13'14"W, a distance of 88.54 to a spike; thence N36°48'29"W, a distance of 172.48 feet to a spike; thence N24°30'42"W, a distance of 63.67 feet to a spike; thence N15°50'44"W, a distance of 218.81 feet to a spike; thence N25°41'54"W, a distance of 233.80 feet to a spike; thence N13°30'49"W, a distance of 65.64 feet to a spike; thence; N10°33'25"E, a distance of 40.62 feet to an iron pipe; thence leaving said right-of-way, N87°05'13"E, a distance of 1437.82 feet to the point of beginning. Subject to and including easments, restrictions, reservations and right-of-ways of record or in use. Said parcel contains 24.93 acres including the water area of Abel Lake. Parcel contains +24.33 acres not including the water area of Abel Lake. Excepting any of those lands lying below the ordinary high water mark of Abel Lake.

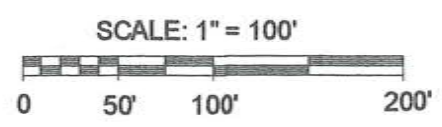
