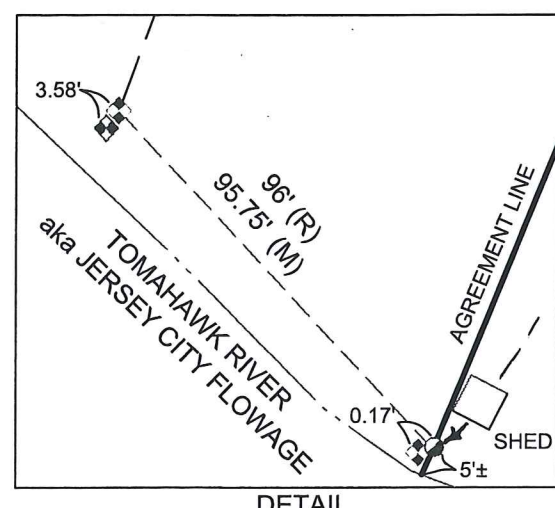
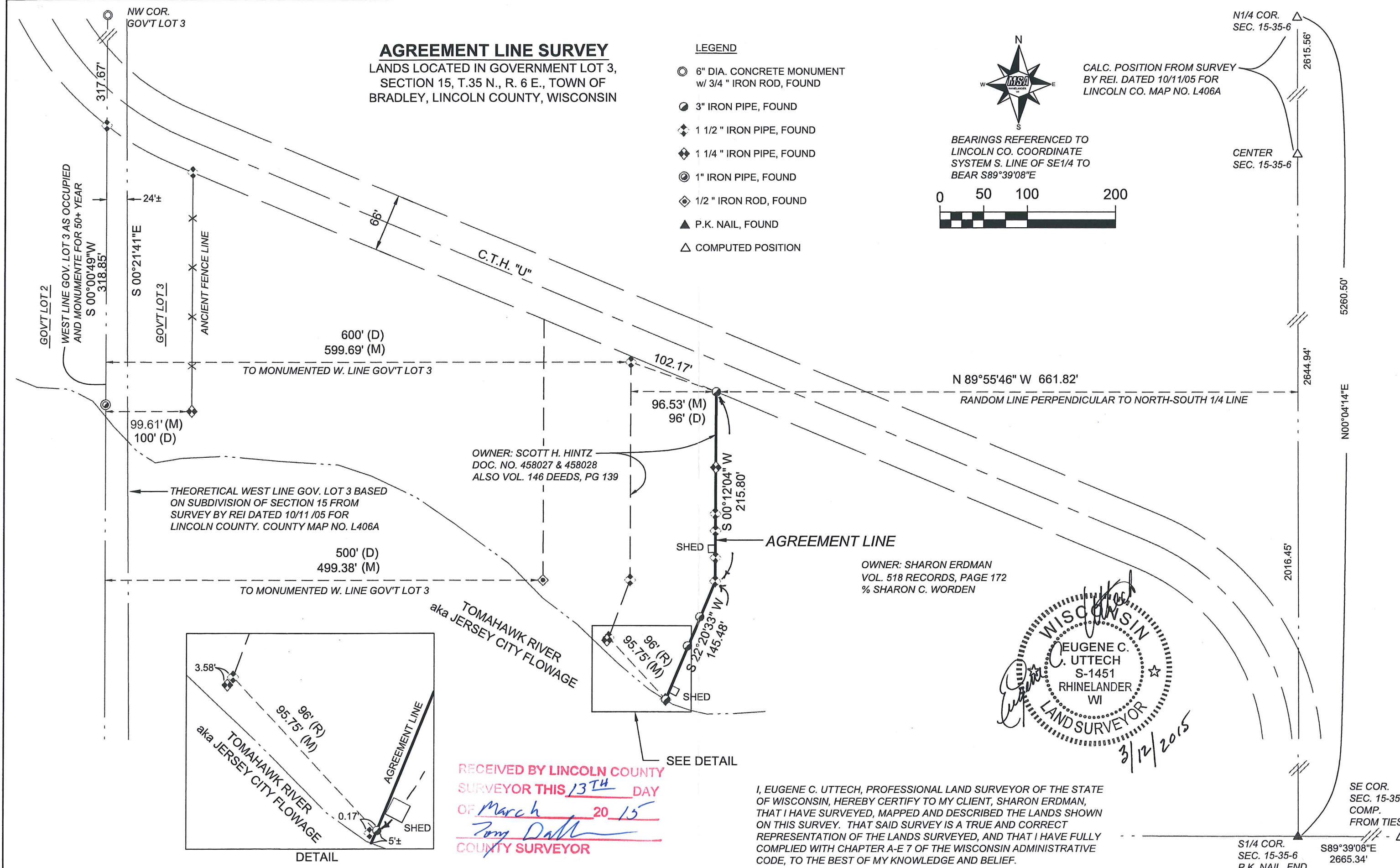
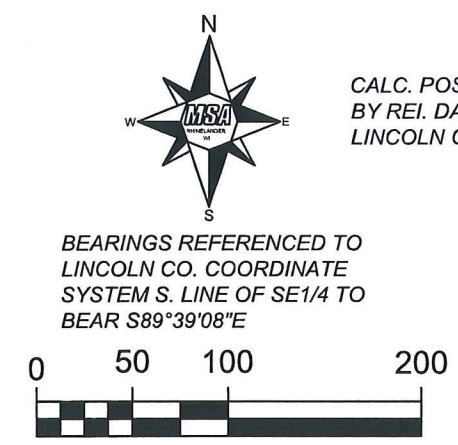

This "Agreement Line" drafted between abutting owners, to deed any interest they have lying on either side of the following described line:

Owner on West side of Agreement Line: Scott H. Hintz

Owner on East side of Agreement Line: Sharon Erdman

This "Agreement Line" located in Government Lot 3 of Section 15, T.35 N., R.6 E., Town of Bradley, Lincoln County, Wisconsin and being more particularly described as follows:

Commencing at the South 1/4 corner of said Section 15; thence N.00°04'14"E., along the North-South 1/4 line of said Section 15, a distance of 2016.45 feet; thence N.89°55'46"W., being a random line, perpendicular to said North-South 1/4 line, a distance of 661.82 feet to a 3" diameter iron pipe found on the southerly right-of-way line of C.T.H. "U" and being the point of beginning of "Agreement Line" to be described; thence S.00°12'04"W., a distance of 215.80 feet to a 1 1/2" diameter iron pipe found; thence S.22°20'33"W., a distance of 145.48 feet to a 3" diameter iron pipe found near the northerly shore of the Tomahawk River; thence continuing S.22°20'33"W., a distance of 5 feet, more or less to the ordinary high water line of said Tomahawk River and being the point of termination of said "Agreement Line".
