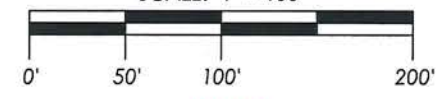

West line of the East Half of the Southwest Quarter

The West line of the East half of the Southwest Quarter of Section 14, Township 35 North, Range 7 East, Town of King, Lincoln County, Wisconsin, as described as follows:

Commencing at the West Quarter Corner of Section 14, marked by a Berntsen Monument, thence S89°34'25"E, along the North line of the Northwest Quarter of the Southwest Quarter, a distance of 1285.43 feet to the Center - West Sixteenth Corner, being the place of beginning, marked by an iron pipe.

Thence S00°02'04"E, along the West line of the East Half of the Southwest Quarter, a distance of 2601.28 feet to the Northerly right of way of County Road "A", being the place of termination of said line, marked by a capped rebar.
