SURVEYOR'S CERTIFICATE

I JOSHUA W. PRENTICE, WISCONSIN PROFESSIONAL LAND SURVEYOR S-2852, DO HEREBY CERTIFY TO THE BEST OF MY KNOWLEDGE AND BELIEF: THAT I HAVE SURVEYED AND MAPPED PART OF GOVERNMENT LOT 2, OF SECTION 12, TOWNSHIP 31 NORTH, RANGE 6 EAST, CITY OF MERRILL, LINCOLN COUNTY, WISCONSIN, MORE PARTICULARLY DESCRIBED AS FOLLOWS: COMMENCING AT THE NORTH I/4 OF SAID SECTION 12, THENCE SOUTH 00°01'29" EAST, COINCIDENT WITH THE NORTH-SOUTH 1/4 LINE OF SAID SECTION 12, 4958.74 FEET; THENCE SOUTH 89°58'31" WEST, 182.20 FEET TO THE SOUTH RIGHT-OF-WAY LINE OF THE CANADIAN NATION RAILROAD, THE BEGINNING OF A CURVE CONCAVE TO THE NORTHWEST, AND THE POINT OF BEGINNING; THENCE 112.85 FEET COINCIDENT WITH SAID SOUTH RIGHT-OF-WAY LINE OF THE CANADIAN NATIONAL RAILROAD AND THE ARC OF SAID CURVE, SAID CURVE HAVING A RADIUS LENGTH OF 776.28 FEET, A CENTRAL ANGLE OF 08°19'44", AND A CHORD THAT BEARS SOUTH 71°32'22" WEST FOR II2.75 FEET; THENCE SOUTH 75°42'13" WEST, 145.98 FEET TO A POINT BEING THE BEGINNING OF A MEANDER LINE ALONG THE NORTH BANKS OF THE WISCONSIN RIVER AND THE PRAIRIE RIVER, SAID POINT BEING NORTH 75°42'13" EAST, 25 FEET MORE OR LESS FROM THE WATER'S EDGE OF SAID WISCONSIN RIVER; THENCE NORTH 54°36'03" WEST, COINCIDENT WITH SAID MEANDER LINE, 87.37 FEET TO A POINT ON SAID SOUTH RIGHT-OF-WAY LINE OF THE CANADIAN NATIONAL RAILROAD, SAID POINT BEING SOUTH 78° EAST, ±116 FEET MORE OR LESS FROM THE WATER'S EDGE OF THE PRAIRIE RIVER, COINCIDENT WITH SAID SOUTH RIGHT-OF-WAY LINE OF THE CANADIAN NATIONAL RAILROAD, AND THE BEGINNING OF A CURVE CONCAVE TO THE NORTHWEST; THENCE 323.96 FEET COINCIDENT WITH SAID SOUTH RIGHT-OF-WAY LINE OF THE CANADIAN NATIONAL RAILROAD, SAID CURVE HAVING A RADIUS LENGTH OF 813.98 FEET, A CENTRAL ANGLE OF 22°48'12", AND A CHORD THAT BEARS NORTH 86°09'45" EAST, 321.83 FEET TO THE POINT OF BEGINNING; INCLUDING THOSE LANDS LYING BETWEEN THE ABOVE DESCRIBED MEANDER LINE, THE NORTH AND SOUTH LINES EXTENDED TO THE WATER'S EDGE OF THE PRAIRIE RIVER AND THE WISCONSIN RIVER.

THAT SAID PARCEL CONTAINS ±8,749 SQUARE FEET OR ±0.201 ACRES MORE OR LESS.

THAT I HAVE MADE THIS SURVEY AND MAP THEREOF AT THE DIRECTION OF THE MERRILL RIVER DISTRICT FOUNDATION, AGENT OF SAID PARCEL.
