PRENTICE, WISCONSIN PROFESSIONAL LAND SURVEYOR S-2852, DO HEREBY CERTIFY TO THE BEST OF MY KNOWLEDGE AND BELIEF: THAT I HAVE SURVEYED AND MAPPED OF ALL OF LOTS 7 OF THE ANDERSON'S LAKE FRONT LOTS AND ALL OF PARCEL I OF CERTIFIED SURVEY MAP NUMBER 210, RECORDED IN VOLUME I, ON PAGE 256, AS DOCUMENT NUMBER 249463, ALL FILED IN THE LINCOLN COUNTY REGISTER OF DEEDS OFFICE, LOCATED IN GOVERNMENT LOT 2, SECTION 35, TOWNSHIP 33 NORTH, RANGE 6 EAST, TOWN OF ROCK FALLS, LINCOLN COUNTY, WISCONSIN, MORE PARTICULARLY DESCRIED AS FOLLOWS:

COMMENCING AT THE NORTH I/4 CORNER OF SAID SECTION 35; THENCE NORTH 89°09'54" WEST, COINCIDENT WITH THE NORTH LINE OF THE NORTHWEST I/4, 250.69 FEET; THENCE SOUTH 00°50'06" EAST, I749.26 FEET TO THE NORTH RIGHT-OF-WAY LINE OF RESORT DRIVE, THE SOUTHWEST CORNER OF LOT 7 OF ANDERSON'S LAKE FRONT LOTS AND THE POINT OF BEGINNING; THENCE NORTH 44°00'55" EAST, 67.00 FEET TO A POINT BEING THE BEGINNING OF A MEANDER LINE ALONG THE SOUTH SHORE OF TUG LAKE, SAID POINT BEING SOUTH 44°00'55" WEST, 39 FEET, MORE OF LESS FROM THE WATER'S EDGE OF SAID TUG LAKE; THENCE SOUTH 43°02'48" EAST, COINCIDENT WITH SAID MEANDER LINE, 60.04 FEET TO THE NORTHWEST MEANDER CORNER OF SAID PARCEL I; THENCE SOUTH 72°01'15" EAST, COINCIDENT WITH SAID MEANDER LINE, 66.73 FEET TO A POINT BEING THE NORTHEAST MEANDER CORNER OF SAID PARCEL I AND THE END OF SAID MEANDER LINE, SAID POINT BEING SOUTH 44°00'55" WEST, ±27 FEET FROM SAID WATER'S EDGE OF TUG LAKE; THENCE SOUTH 44°00'55" WEST, 95.30 FEET TO THE SOUTHWEST CORNER OF SAID PARCEL I AND SAID NORTH RIGHT-OF-WAY LINE OF RESORT DRIVE; THENCE NORTH 44°59'18" WEST, COINCIDENT WITH SAID NORTH RIGHT-OF-WAY LINE OF RESORT DRIVE, I19.94 FEET TO SAID SOUTHWEST CORNER OF SAID LOT 7 AND THE POINT OF . BEGINNING.

INCLUDING ALL THOSE LANDS LYING BETWEEN THE ABOVE DESCRIBED MEANDER LINE, THE WATER'S EDGE OF TUG LAKE, AND THE EAST AND WEST LINES EXTENDED TO SAID WATER'S EDGE OF TUG LAKE.


THAT SAID PARCELS OF LAND CONTAINS ±12,139 SQUARE FEET OR ±0.278 ACRES MORE OR LESS
