

PRENTICE, WISCONSIN PROFESSIONAL LAND SURVEYOR S-2852, DO HEREBY CERTIFY TO THE BEST OF MY KNOWLEDGE AND BELIEF: THAT I HAVE SURVEYED AND MAPPED VACATED CEDAR STREET, BEING PART OF THE NORTHWEST 1/4 OF THE NORTHEAST 1/4 OF SECTION 12, TOWNSHIP 31 NORTH, RANGE 6 EAST, CITY OF MERRILL, LINCOLN COUNTY, WISCONSIN, MORE PARTICULARLY DESCRIBED AS FOLLOWS: COMMENCING AT THE NORTH 1/4 CORNER OF SAID SECTION 12; THENCE SOUTH 89°00'16' EAST, COINCIDENT WITH THE NORTH LINE OF SAID NORTHEAST 1/4, \$253.27 FEET; THENCE SOUTH 00°59'44' WEST, 1029.25 FEET TO THE INTERSECTION OF THE SOUTH GIGHT-OF-WAY LINE OF CENTER AVENUE AND THE EAST RIGHT-OF-WAY LINE OF CEDAR STREET AND THE POINT OF BEGINNING; THENCE SOUTH 00°02'03" WEST. COINCIDENT WITH SAID EAST RIGHT-OF-WAY LINE OF CEDAR STREET TO THE WEST RIGHT-OF-WAY LINE OF SAID CEDAR STREET; THENCE NORTH 90°57'57" WEST, 66.00 FEET TO THE WEST RIGHT-OF-WAY LINE OF CEDAR STREET; THENCE NORTH 00°02'03" EAST, COINCIDENT WITH SAID WEST RIGHT-OF-WAY LINE OF CEDAR STREET TO THE INTERSECTION OF SAID WEST RIGHT-OF-WAY LINE OF CEDAR STREET AND SAID SOUTH RIGHT-OF-WAY LINE OF CEDAR STREET AND SAID SOUTH RIGHT-OF-WAY LINE OF CENTER AVENUE; THENCE NORTH 50°04'58' EAST, COINCIDENT WITH SAID SOUTH RIGHT-OF-WAY LINE, 86.10 FEET TO SAID INTERSECTION OF THE SOUTH RIGHT-OF-WAY LINE OF CENTER AVENUE AND THE EAST RIGHT-OF-WAY LINE OF CEDAR STREET AND THE POINT OF BEGINNING.
