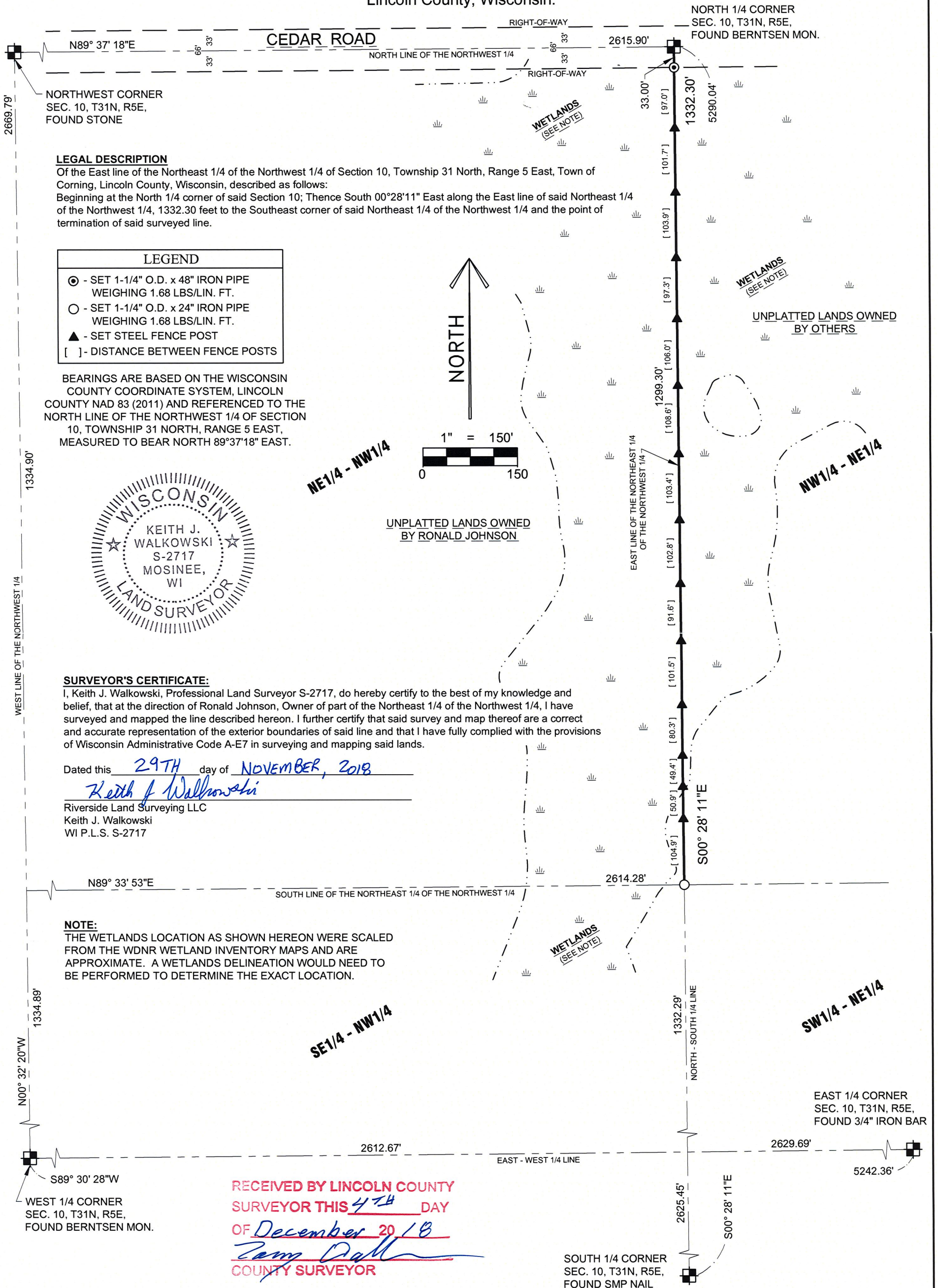


PLAT OF SURVEY

LEGAL DESCRIPTION

Of the East line of the Northeast 1/4 of the Northwest 1/4 of Section 10, Township 31 North, Range 5 East, Town of Corning, Lincoln County, Wisconsin, described as follows:
Beginning at the North 1/4 corner of said Section 10; Thence South 00°28'11" East along the East line of said Northeast 1/4 of the Northwest 1/4, 1332.30 feet to the Southeast corner of said Northeast 1/4 of the Northwest 1/4 and the point of termination of said surveyed line.
