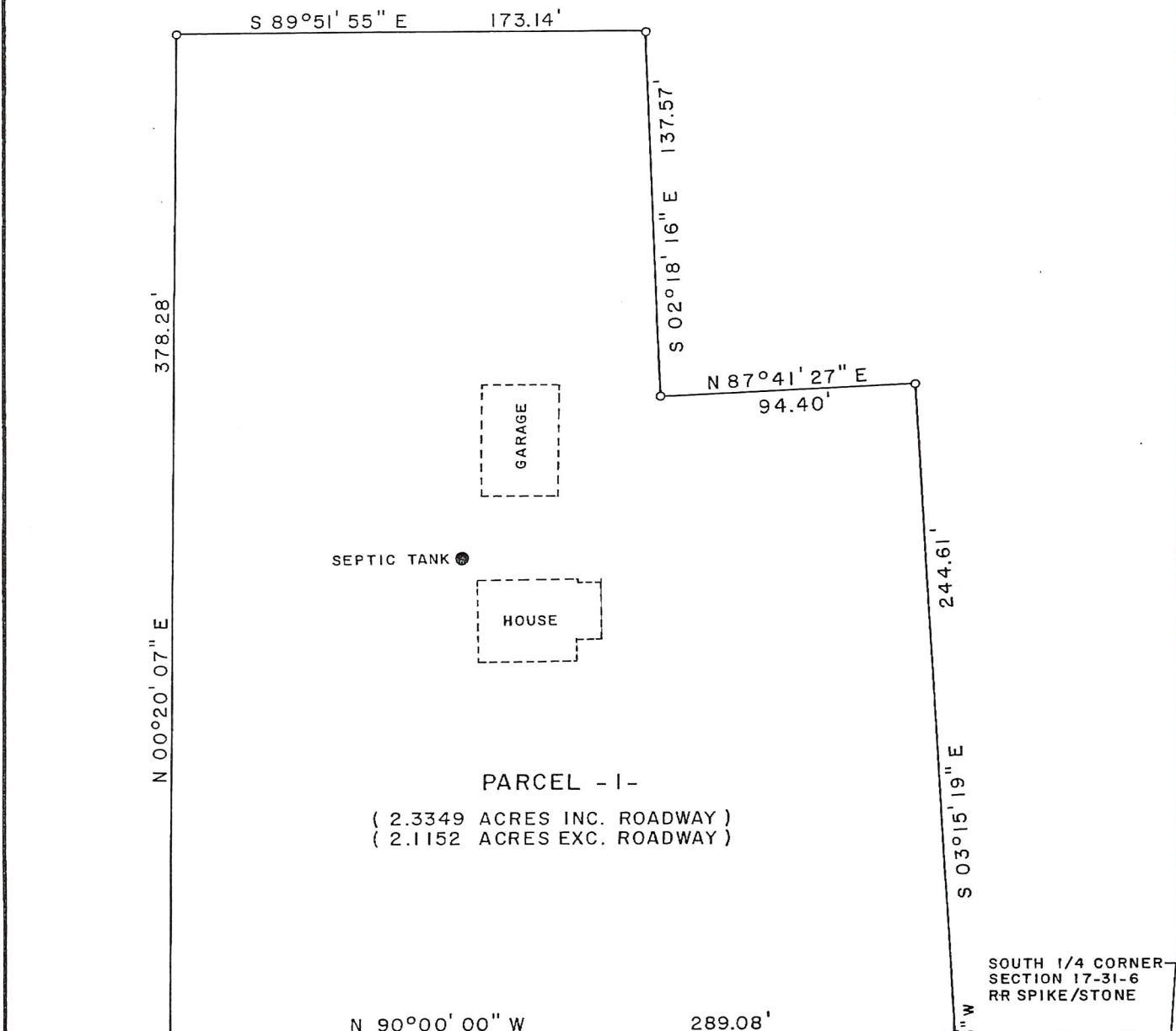


LINCOLN COUNTY CERTIFIED SURVEY MAP

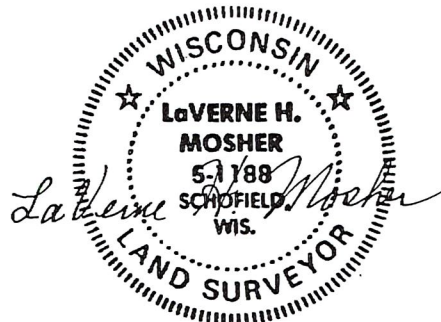

I, LaVerne H. Mosher, Registered Land Surveyor, hereby certify:

That I have surveyed, divided and mapped that part of the Southeast $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of Section 17, Township 31 North, Range 6 East, Town of Scott, Lincoln County, Wisconsin; described as follows:

Commencing at the South $\frac{1}{4}$ corner of said Section 17, Township 31 North, Range 6 East; thence N $90^{\circ} 00' 00''$ W along the South line of the said Southwest $\frac{1}{4}$ of Section 17, 84.98 feet; thence N $03^{\circ} 15' 19''$ W, 33.05 feet to a point on the North line of Joe Snow Road; said point also being the point of beginning of the parcel to be described; thence N $90^{\circ} 00' 00''$ W along the said North line of Joe Snow Road, 289.08 feet; thence running N $00^{\circ} 20' 07''$ E, 378.28 feet; thence S $89^{\circ} 51' 55''$ E, 173.14 feet; thence S $02^{\circ} 18' 16''$ E, 137.57 feet; thence N $87^{\circ} 41' 27''$ E, 94.40 feet; thence S $03^{\circ} 15' 19''$ E, 244.61 feet to the point of beginning.

That I have made such survey, land division and plat by the direction of Fred and Norma Schroder.

That such plat is a correct representation of all exterior boundaries of the land surveyed and the subdivision thereof made.

That I have fully complied with the provisions of Chapter 236.34 of the Wisconsin Statutes, Chapter A-E 7 of the Wisconsin Administrative Code, and the Subdivision Regulations of the County of Lincoln and the Town of Scott in surveying, dividing and mapping the same.
