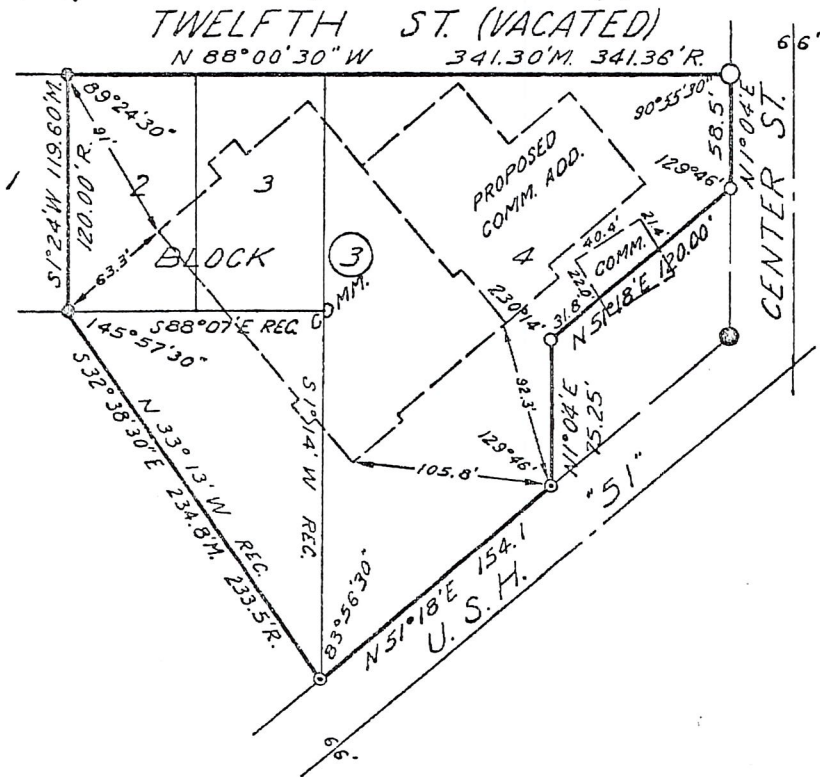
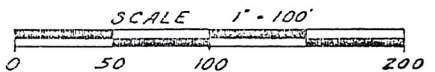


CERTIFIED SURVEY MAP

That such plat is a correct representation of all the exterior boundaries of the land surveyed and the subdivision thereof made.

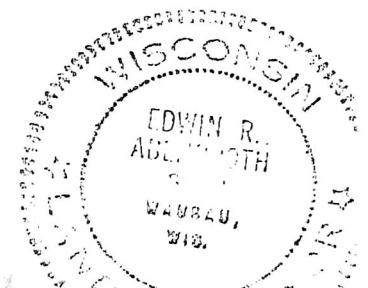
