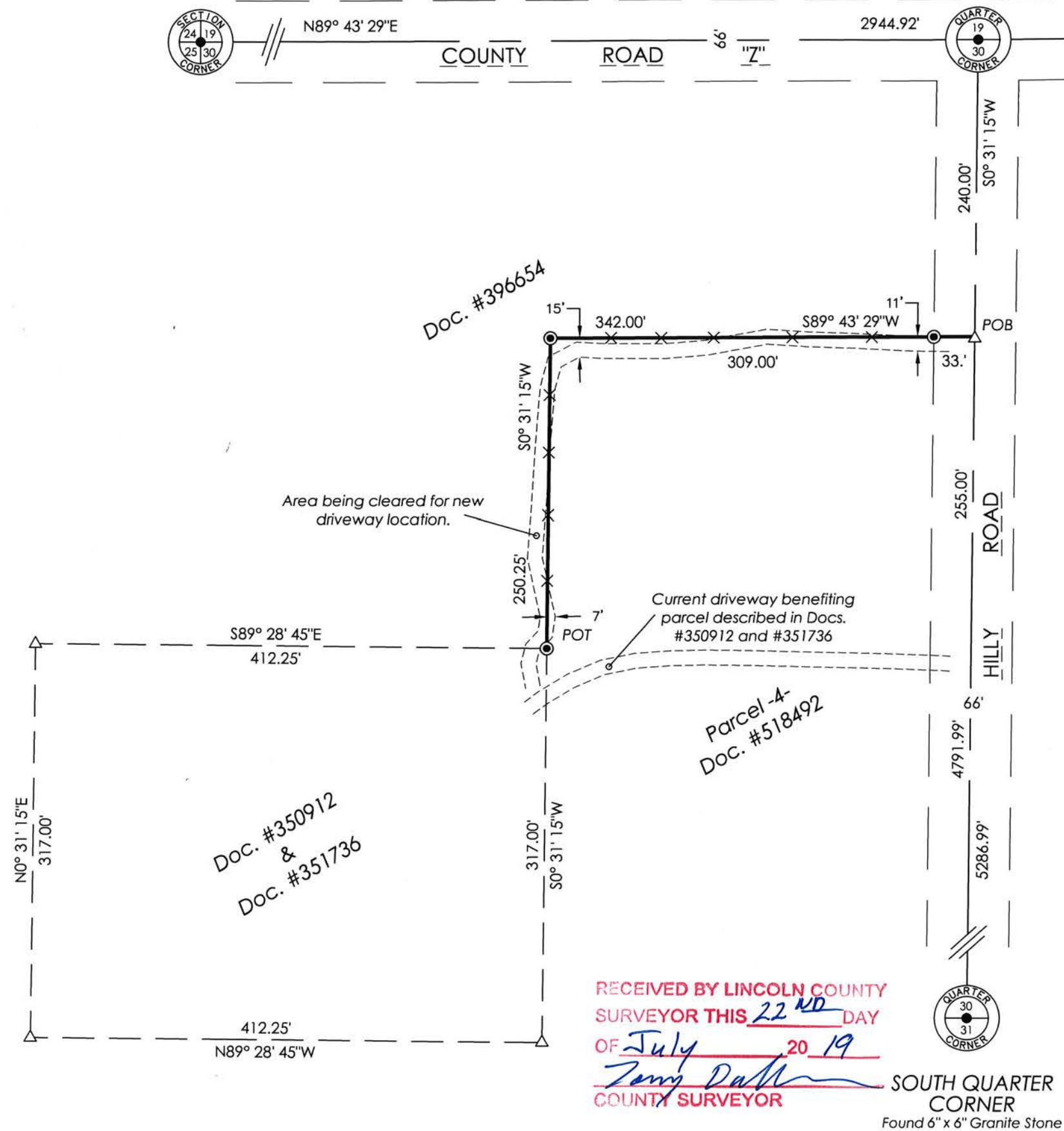


NORTHWEST

DESCRIPTION

A survey of the lines common to Parcel 4 as described in Doc. #518492, and a parcel described in #396654, as recorded in the Lincoln County Register of Deeds, and located in the Northeast Quarter of the Northwest Quarter of Section 30, Township 31 North, Range 6 East, Town of Scott, Lincoln County, Wisconsin, more particularly described as follows:

Commencing at the North Quarter Corner of Section 30, marked by a nail, thence S0°31'15\"W, along the East line of the Northwest Quarter, a distance of 240.00 feet to the point of beginning.

Thence, S89°43'29\"W, along the north line of Parcel 4 of Doc. #518492, a distance of 342.00 feet the west line of said Parcel 4, to a rebar; thence S0°31'15\"W, along said west line, a distance of 250.25 feet to the Northeast Corner of Doc. #350912, to the point of termination, marked by a rebar.

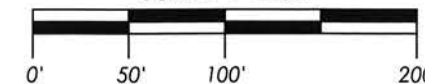
