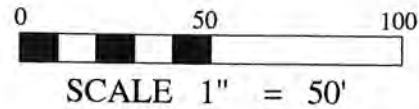

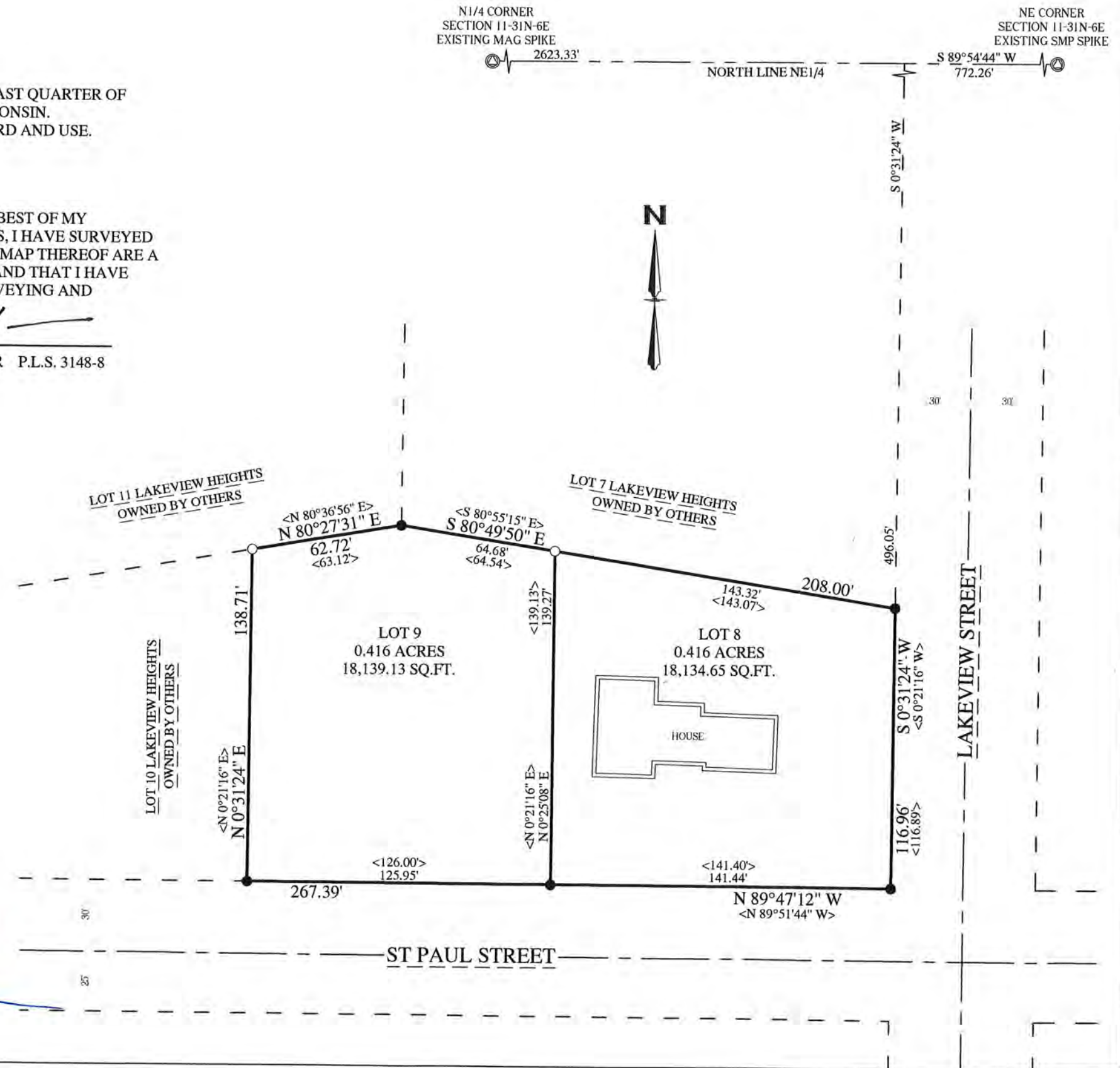


BEARINGS REFERENCED TO THE NORTH
