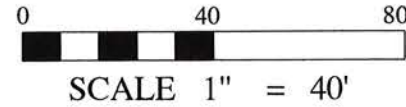


# PLAT OF SURVEY

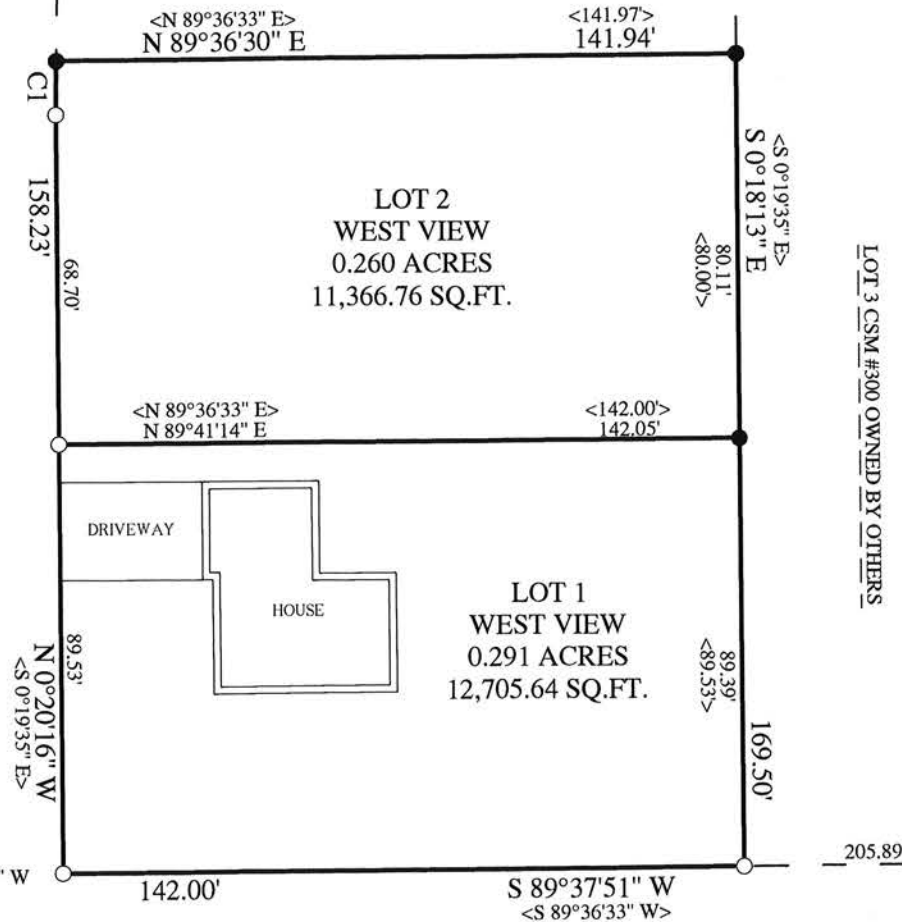
