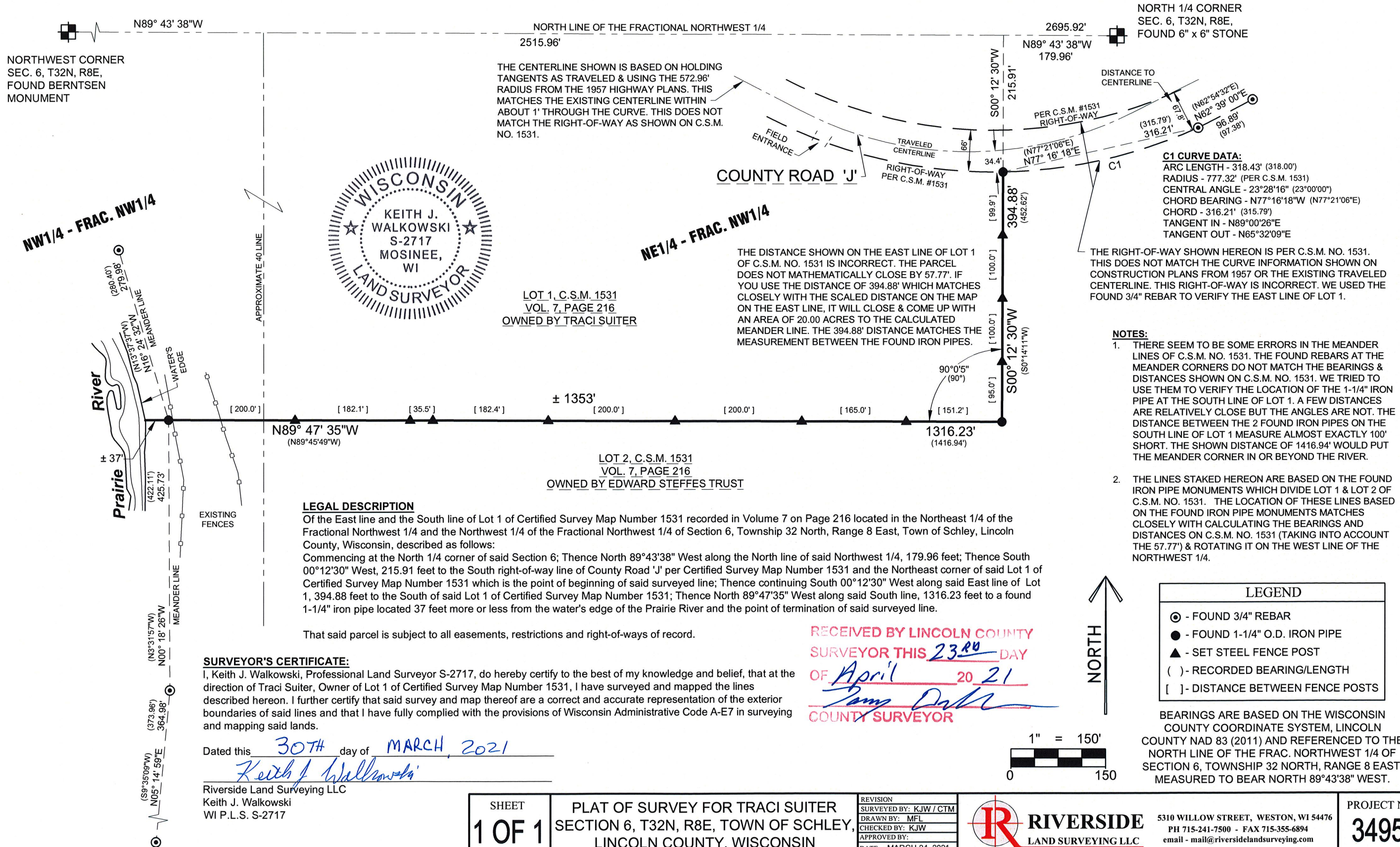


# PLAT OF SURVEY

Of the East line and the South line of Lot 1 of Certified Survey Map Number 1531 recorded in Volume 7 on Page 216 located in the Northeast 1/4 of the Fractional Northwest 1/4 and the Northwest 1/4 of the Fractional Northwest 1/4 of Section 6, Township 32 North, Range 8 East, Town of Schley, Lincoln County, Wisconsin.



**LEGAL DESCRIPTION**

Of the East line and the South line of Lot 1 of Certified Survey Map Number 1531 recorded in Volume 7 on Page 216 located in the Northeast 1/4 of the Fractional Northwest 1/4 and the Northwest 1/4 of the Fractional Northwest 1/4 of Section 6, Township 32 North, Range 8 East, Town of Schley, Lincoln County, Wisconsin, described as follows:  
 Commencing at the North 1/4 corner of said Section 6; Thence North 89°43'38" West along the North line of said Northwest 1/4, 179.96 feet; Thence South 00°12'30" West, 215.91 feet to the South right-of-way line of County Road 'J' per Certified Survey Map Number 1531 and the Northeast corner of said Lot 1 of Certified Survey Map Number 1531 which is the point of beginning of said surveyed line; Thence continuing South 00°12'30" West along said East line of Lot 1, 394.88 feet to the South of said Lot 1 of Certified Survey Map Number 1531; Thence North 89°47'35" West along said South line, 1316.23 feet to a found 1-1/4" iron pipe located 37 feet more or less from the water's edge of the Prairie River and the point of termination of said surveyed line.

That said parcel is subject to all easements, restrictions and right-of-ways of record.
