

PART OF LOTS 1, 2, AND 3 OF RAPEL SUBDIVISION, LOCATED IN THE NORTHEAST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 4, TOWNSHIP 35 NORTH, RANGE 6 EAST, TOWN OF BRADLEY, LINCOLN COUNTY, WISCONSIN, DESCRIBED AS FOLLOWS: COMMENCING AT THE SOUTHEAST CORNER OF SAID SECTION 4; THENCE N 0°12'32" W ALONG THE EAST LINE OF THE SOUTHEAST OUARTER, 1576.02 FEET; THENCE S 89°47'28" W 393.50 FEET TO THE NORTH LINE OF RAPEL ROAD; THENCE N 74°08'55" W ALONG THE NORTH LINE OF RAPEL ROAD, 17.78 FEET TO THE POINT OF BEGINNING; THENCE CONTINUING ALONG THE NORTH LINE OF RAPEL ROAD, 149.90 FEET TO THE SOUTHWEST CORNER OF LOT (3) OF RAPEL SUBDIVISION; THENCE N 13°39'30" E ALONG THE WEST LINE OF SAID LOT (3), 142.54 FEET TO A POINT BEING 15 FEET MORE OR LESS FROM THE ORDINARY HIGH WATER MARK OF LAKE NOKOMIS AND TO THE BEGINNING OF A MEANDER LINE; THENCE S 73°17'47" E ALONG THE MEANDER LINE, 150.14 FEET TO A POINT BEING 22 FEET MORE OR LESS FROM THE ORDINARY HIGH WATER MARK OF LAKE NOKOMIS AND TO THE END OF THE MEANDER LINE; THENCE S 13°42'59" W ALONG THE WEST LINE OF LOT (1) OF CERTIFIED SURVEY MAP NUMBER (2043), 140.30 FEET TO THE POINT OF BEGINNING. EXCLUDING ALL LANDS LYING BETWEEN THE ORDINARY HIGH WATER MARK OF LAKE NOKOMIS AND A LINE 30 FEET LANDWARD OF THE ORDINARY HIGH WATER MARK OF LAKE NOKOMIS. SUBJECT TO ALL EASEMENTS, RESTRICTIONS, RESERVATIONS AND RIGHTS OF WAY OF RECORD AND USE.
